Annual Environmental Goals

CoastTec 2018 annual goal was to bring in 500,000 lbs. of UPS units from companies/recyclers which were destined for scrap or recycling to be placed in inventory and remanufactured. Actual 2018 lbs. recovered and brought into inventory was 514,013.04 lbs. 2019 goal is an increase to 600,000 lbs.

Environmentally Preferable Products and Services

CoastTec is the only R2: 2013 and RIOS certified refurbisher of American Power Conversion (APC) Uninterruptible Power Supplies (UPS) units and the only company authorized by APC to remanufacture and resell certified pre-owned APC UPS units in the U.S

All CoastTec product is shipped in cardboard boxes with foam inserts. All trade in units returned to CoastTec are shipped back in the original box and the cardboard from the box is recycled and the foam inserts having now already been used for two transits trips will be inspected and if structurally sound will be used on multiple other shipments until such time as the foam is not usable. Once it is determined that the foam inserts are no longer usable they are crushable to 10% of their original volume.

CoastTec is certified R2 (Responsible Recycling (R2) Rev. 7/2013) and RIOS (Recycling Industry Operating Standard Rev. 3.2006)
