*Batteries Plus recycles batteries and select portable electronics. Leading by example, Batteries Plus recycles the majority of batteries we sell. Not only do we recycle to protect our environment, we also keep our customers in full compliance with all federal, state, municipal, EPA and DOT regulations governing disposal and recycling of batteries and small electronics.*

### Recycling

*We have implemented an office recycling program where we collect all waste materials that cannot be reduced or reused. There are clearly labeled bins in our office area that are easily accessible (paper, cans, glass, and batteries). The ink and toner cartridges are taken to an office supply store for recycling. The waste materials collected will be dropped off at the following facility:*

### Energy Efficiency

*We have installed Energy Star qualified compact fluorescent light bulbs (CFL) that will save us about \$30 over their lifetime and pay for itself in about 6 months. CFLs use 75 percent less energy and last about 10 times longer than an incandescent bulb. For example, our electric bill went from \$500 per month to a little over \$300 per month.*

*For a few of our local clients, employees will report to the office and take one of our fleet vehicles together as a way of reducing gas consumption and fuel costs, vehicle emissions, and vehicle maintenance.*
