• Hatcher & Ecologix Outreach Work Brian updated the SC on the work of Hatcher (result of Town Creek funding) and Ecologix. There are five one-pagers being drafted on topics previously approved. As they are developed we will share drafts for review. Both will do a full update at the June Meeting. Tad suggested that the State Agencies with outreach efforts update as well (DNR & DHMH).

## 3. Standing Reports

- Working Group Updates
  - Scientific and Technical Working Group The last meeting took place on 4/26, planning another for 6/20 that will include MDOT, MACo, and others. Details to follow.
  - Adaptation and Response Working Group ARWG met this past Monday, working with MDP on local government surveys about what locals need and want; what they are already implementing.
  - Mitigation Working Group The recent meeting on Healthy Soils went well. Next two meetings are in the works. It was mentioned that it might help to share more newsworthy items with the commission and other stakeholders. Some members expressed an interest in also keeping up with the work of the PSC. There was discussion on what this could look like. The idea of a newsletter was mentioned as well. As we moved into the outreach discussion, Secretary Grumbles expressed

support of an effort to make a newsletter work, but stressed it should be well thought out and not overly time consuming so it does not distract from other duties.

 Education, Communication, and Outreach Working Group A new co-chair, John Kumm, will be working with the working group. Allison described efforts going on in addition to the Hatcher and Ecologix work including gathering a tool kit with information about climate related topics and a social media campaign based around images of climate change in the community. Allison continues to work with CEJSC & CEHPAC on these issues as well.
