efficiency, air emission standards and renewable sources of energy, all of which may impact Maryland's environment.

The General Assembly also is considering legislation, House Bill 590 and Senate Bill 509, which would implement an emissions inspection program for diesel vehicles. The roadside inspection program would be jointly regulated by the Department of the Environment, Department of Transportation and Maryland State Police.

Two other bills, House Bill 502 and Senate Bill 323, will require MDE to post ambient air monitoring data on the internet for public access. Senate Bill 599 would require nearby property owners to be notified of a proposed incinerator or landfill. House Bill 21, which would extend the sunset date for the Governor's Advisory Council on Environmental Justice, has been passed by the House.

The end of the 1999 Legislative Session of the Maryland General Assembly, Sine Die, is midnight April 12. The May edition of the *MDEnvironment* will contain a final legislative wrap up to inform you of the disposition of these pieces of legislation.

# **Waste Management** Administration February 19 – March 15, 1999 For more information contact (410) 631-3535

C.W. Lord Company, Inc., Wicomico County- A Complaint, Order and Civil Penalty for \$32,000 was issued against C.W. Lord Company, Inc. on February 26, 1999 for violating Maryland Oil Pollution Laws. This action resulted from the company's failure to have underground storage tank financial responsibility for the thirteen underground storage systems it operates at its convenience stores.

Status: Pending (Reference COV-99-

1998 Underground Storage Tank **Deadline Consent Agreements - As** of March 15, 1999, twenty-two consent agreements have been entered into across the State regarding continued operation of non-compliant underground storage systems. The tank owners did not achieve compliance with the Underground Storage Tank upgrade deadline of December 22, 1998. The Consent Agreement allows the operation of the storage systems after the owners have met stringent release detection requirements and maintain pollution liability insurance. All the owners involved have made arrangements to have their tank systems upgraded to come into compliance within six months of the Agreement. There are stipulated penalties for tank owners not complying with the agreement. Also, some of the multiple tank owners will have to pay monthly penalties while operating in non-compliance.

# Johnson Controls - Baltimore County

On February 19, 1999, MDE signed an administrative consent order with Johnson Controls, Inc. requiring improvements to the unloading operations area, including the completion of a rail siding enclosure and a secondary containment system. Johnson Controls has paid a \$5,000.00 administrative penalty for water pollution violations.

Status: Case closed. (Reference # CO-99-0054).

Rodney Harbaugh - Carroll County

On February 16, 1999, MDE issued a unilateral administrative complaint and order to Rodney Harbaugh requiring the number of hogs maintained on the farm be reduced to below the threshold of 1000 animal units until a CAFO permit is obtained. The order also required that no manure is land applied until nutrient management and animal waste system plans are approved by MDE.

Mr. Harbaugh requested an administrative hearing, which is currently underway at OAH.
