Comment Sought on Proposed 1999 Standard Permit Application **Turnaround Times**

by John Mitchell

First established in 1996, Maryland Department of the Environment's (MDE) standard permit application turnaound times are updated annually in consultation with businesses, environmental advocates and many other interested stakeholders. Following on page 11 are the proposed 1999 standard permit application turnaound times.

Through January 31, 1999 interested parties are invited to comment in writing or in person on this proposal. Anyone with comments about these standard turnaround times is invited to call John Mitchell in MDE's Environmental Permits Service Center at (410) 631-3772. After responding to stakeholder input, MDE will publish the final 1999 permit turnaround times in the MDEnvironment and the Maryland Register.

Please note that there are two proposed changes from 1998. First, MDE proposes to change the permit turnaround time for the Sewage Sludge **Utilization Permit for Transportation** from three months to four because the distribution of sludge has increased and an increase in transportation permits for transportation of sewage sludge out of state is anticipated. Secondly, MDE proposes to change the permit turnaround time for the Sewage Sludge Utilization Permit for Land Application from six months to ten months. While the department has made every effort to achieve the six month turnaround

time goal, our experieince indicates that a complete and proper review involves numerous internal and external stakeholder reviews which make the six month goal unattainable.

In most permitting programs, each application has unique characteristics that influence its processing time. For each program listed, the standard time represents the time in which 90% of applications can be processed. Many applications will require less time; a few will require more time due to unusual circumstances.

The permit turnaround time standards refer to the time between MDE's receipt of a complete permit application and MDE's issuance or denial of the permit, excluding delays caused by factors beyond MDE's control. Many applications are incomplete when they first arrive at MDE. The Environmental Permits Service Center or the appropriate MDE permit writer can provide tips on how to ensure that an application is complete when submitted.

Unfortunately, there are factors beyond MDE's control that can delay the processing of permit applications. Examples include delays in receiving information needed from the applicant and delays in obtaining necessary approvals from local or federal government agencies. MDE's permitting personnel can provide advice about avoiding such delays.

The DRAFT Integrated Project Priority System (IPPS) for the Water Quality Revolving Loan Fund Program (WQSRF or WQRLF), and the revised definition of Disadvantaged Community under the Drinking Water Revolving Loan Fund (DWSRF or DWRLF) will be the subject of a public hearing to be held on February 10, 1999 at 10 a.m. in the Potomac Conference Room, Second Floor, of the Maryland Department of the Environment located at 2500 Broening Highway, Baltimore, Maryland.

Draft Integrated Project Priority System for WQSRF

The Department has developed an Integrated Project Priority System (IPPS) that will be used to select Water Quality improvement projects for financial assistance through the WQSRF Program. The draft IPPS outlines the criteria and procedures for rating and ranking wastewater, non-point source and estuary management projects into a single priority list. (Drinking Water SRF projects will continue to be rated and ranked through a separate Project Priority Rating System.)

Revised Definition of "Disadvantage Community" under DWSRF

The Department is proposing a change in its definition of Disadvantage Community under the DWSRF Program. The new definition will allow communities in Maryland that experience significant water rate increases, as a result of a compliance order or other system upgrades, to qualify for a 30-year loan term, a lower interest rate, and other subsidies permitted under the Federal Safe Drinking Water Act.

Copies of the Draft Integrated Project Priority System for WQSRF and the revised definition of "Disadvantage Community" under DWSRF have been mailed to local governments and eligible private water systems, and will be available upon request on or after January 5, 1999 from the Maryland Department of the Environment, Water Management Administration, 2500 Broening Highway, Baltimore, Maryland, 21224, (410) 631-3574.

Persons wishing to comment on the proposed Draft Integrated Project Priority System for WQSRF and the revised definition of "Disadvantaged Community" under DWSRF may submit their views in writing to the address listed above (Attn: Virginia Kearney), or in person at the hearing. It is requested that persons presenting prepared statements at the time of the hearing provide two (2) copies to the Hearing Officer. The hearing record will close on Wednesday, February 17, 1999.

Phoenix Color Corporation - Washington County - MDE has issued an Administrative Corrective Order to this printing company for constructing and installing numerous printing presses without permits and for operating certain of its presses in violation of substantive VOC requirements. The violations were discovered during an inspection of the facility.

Status: The Company has ten days to appeal the Corrective Order. (Reference # 98-08-05)

Citgo Petroleum - Baltimore City -MDE assessed an \$11,000 administrative penalty against Citgo for air quality violations at its gasoline distribution terminal located in Fairfield. Odor complaints lodged by neighbors of the facility led to an investigation by MDE. The investigation determined that there were several gasoline spills at the terminal during the filling of gasoline tank trucks. These spills created air pollution violations including creation of an odor nuisance and failure to take proper precautions to control gasoline vapors during loading.

Status: The Company has 30 days to request a hearing on the penalty. (Reference # 98-11A)

Crown Cork & Seal - Wicomico County - MDE assessed a \$39,000 administrative penalty against Crown Cork & Seal for violations of Volatile Organic Compound (VOC) requirements at its can manufacturing one of the coatings used at the facility exceeded allowable VOC limits. In response to an earlier Corrective Order issued by MDE, the Company has reformulated the coating and is now operating in compliance.

Status: The Company has 30 days to request a hearing on the penalty. Ref# 98-16A

Tanknology--NDE, Baltimore

County - On November 23, 1998 a Complaint and Order involving a \$22,000 penalty was issued against Tanknology--NDE, a national tank testing and upgrade company. This action resulted from the company's completion of two recent upgrade installations at service stations, utilizing personnel not properly certified by MDE. Actions taken by Tanknology personnel caused the destruction of a gasoline product line at one of the sites, resulting in a release of product.

Status: Pending (Reference #COV-99-034)

Maritank, Inc.--Wicomico County - The Complaint and Order listed in the June 1998 *MDEnvironment* has been settled for \$10,000. The penalty was issued to the company for an overfill which occurred during a marine transfer. The operator failed to heed the overfill alarm and cease the transfer which would have prevented the release. The company also failed to report the spill in a timely manner. **Status**: Settled (Reference #COV-98-

034)

General Die Finishing - Baltimore County - The Complaint and Administrative Penalty for improper disposal and management of hazardous waste listed in the March 1998 *MDEnvironment* has been settled for \$7,500. The penalty was issued because the company stored and treated hazardous wastewater and waste materials without a permit and disposed of hazardous waste in their general dumpster.

Status: Settled (Reference #NOV-98-042)

Columbia Country Club - Montgomery County - The Notice of Violation listed in the August 1998 *MDEnvironment* has been settled for \$7,500. The penalty was imposed because the Club buried herbicide with other containers of turf chemicals. Investigation revealed that the herbicide leaked into the burial pit. Status: Settled (Reference #NOV-98-042)
