

Enforcement and Compliance Notes



Air and Radiation Management Administration May 13 - June 12, 1998

Solarex - Frederick County

On June 2, 1998, MDE assessed an administrative penalty in the amount of \$16,500 against Solarex for the company's failure to secure the proper air quality permits prior to installing an automated field screen printing unit that consisted of material applicators and various ovens and furnaces. **Status:** The company has 30 days in which to request a hearing to contest the penalty. (Reference # ACP 98-03A)

Baltimore Gas and Electric Co. - Anne Arundel County

On May 20, 1998, MDE issued a complaint and order to the Baltimore Gas and Electric Company. The complaint alleged that on 17 separate days in 1996 and 1997 the company exceeded a regulatory standard for emissions of nitrogen oxides at the company's Brandon Shores facility. The order requires the company to report on the causes of the exceedences and to develop a plan for maintaining compliance with the regulatory limit. The Department is considering assessing a financial penalty for the violations.

Status: The company has appealed the order by requesting a hearing. (Reference #97-09-01)

Law Engineering - Chantilly, Virginia and Columbia, Maryland

On May 27, 1998, MDE assessed an administrative penalty against Law Engineering in the amount of \$13,000 for the company's failure to notify MDE of conducting activities in Maryland, under the company's NRC license issued in Virginia, involving the use of a soil testing gauge that uses a radioactive material; for the failure to properly secure the gauge, which resulted in its loss; for the failure to immediately report the loss of the gauge to MDE; and for the failure to either apply for a renewal of or to terminate its Maryland-issued license to possess or use radioactive materials. Status: The company has 30 days in which to appeal the assessed penalty. (Reference # RHP-98-06)

Nucletron Corporation - Baltimore City On May 26, 1998, MDE assessed an administrative penalty in the amount of \$6,500 against Nucletron Corporation for violating the terms of the company's license issued for the purpose of distributing and servicing radioactive devices in Maryland. Specifically, the company failed to notify MDE of modifications made to a mobile van housing a radioactive source and of a Nucletron-owned equipment deficiency in Virginia, for failure to supply radiation exposure monitoring badges to its field engineers, and for failure to properly implement a radiation safety program to maintain radiation exposure to radioactive materials as low as reasonably achievable.

Status: The company has 30 days in which to appeal the assessed penalty. (Reference # RHP-98-05)

North Arundel Hospital - Anne Arundel County

On May 26, 1998, MDE assessed an administrative penalty against the North Arundel Hospital in the amount of \$12,000 for violating the terms of its license for the possession and use of radioactive materials for medical purposes. The violations included recordkeeping and employee safety deficiencies and radiation contamination testing deficiencies in the Nuclear Medicine Department. **Status:** The hospital has 30 days in which to appeal the assessed penalty (Reference # RHP-98-04)

EBA Engineering - Baltimore City

On May 27,1998, MDE assessed an administrative penalty against EBA Engineering in the amount of \$6,800 for violating the terms of its license for the possession and use of radioactive materials. Specifically, the company failed to immediately notify MDE that a soil density gauge containing a radioactive material had been lost from a construction site in Odenton, allowed someone not covered by the company's license to use a gauge containing a radioactive source, failed to post proper warning signs, and operated a gauge containing a radioactive source in an improper manner. Status: The company has 30 days in

which to appeal the assessed penalty. (Reference #RHP-98-01)

Waste Management Administration May 9 - June 12, 1998

Landlords - Baltimore City; Allegany, Frederick and Carroll Counties Fourteen notices of failure to register rental properties were mailed to landlords in May 1998 for a total of \$83,930. The breakdown by jurisdiction is as follows: Baltimore City - \$50,740; Allegany County - \$18,900; Frederick County -\$1820; Carroll county - \$12,470. Status: Pending (Various reference numbers)

Petro-Tech - Charles County

The Complaint & Order listed in the August 1997 *MDEnvironment* has been settled for \$2,000. The penalty was issued to the company for failure to remove underground storage tanks in a safe manner and for the discharge of oil onto the ground at their La Plata Facility. **Status:** Settled (Reference #COV-97-049)

E2CR, Inc. - Baltimore County

The Complaint and Order listed in the November 1997 *MDEnvironment* has been settled for \$3,750. The penalty was issued for improper removal of two underground storage tanks and the subsequent discharge of oil onto the ground at the MD National Guard facility in Essex. The company has finished all clean-up activities.

Status: Settled (Reference #COV-97-062)

Water Management Administration May 12 – June 11, 1998

Daniel Dixon – Charles County

On May 29, 1998, MDE reached a final settlement with Daniel Dixon regarding the requirements of a March 20, 1996 administrative consent order requiring repairs to a failing residential septic system. Mr. Dixon has paid a \$3,500 stipulated penalty for delays in completing the required improvements to his septic system within the time frame established by the consent order. **Status:** Case closed. (Reference #CO-032096).

Montgomery County Leaf Composting Facility - Montgomery County

On June 3, 1998, MDE signed an administrative consent agreement with the Montgomery County Department Of Public Works and Transportation, and the Maryland Environmental Service (MES) to resolve NPDES violations at the Montgomery county Leaf Composting Facility located in Dickerson. The settlement requires that a corrective action plan be implemented to address storm water treatment improvements and includes a \$19,500 penalty for biochemical oxygen demand (BOD) and total suspended solids (TSS) effluent violations, and for unauthorized discharges of discolored, foamy water from the facility's storm water pond. The consent agreement also provides for an additional penalty payment of \$5,500 if MDE determines there are any future significant pollution events originating from the facility which impact the receiving waters, as well as separate stipulated penalties for future additional permit effluent violations. The agreement also requires that a supplemental environmental project (SEP) to benefit water quality and valued at least \$25,000 be performed within the next two years.

Status: Case Pending. (Reference # CO-98-0080).

Driggs Corporation - Baltimore County

On May 21, 1998, MDE issued an administrative complaint and penalty assessment against the Driggs Corporation for sediment control and sediment pollution violations at the Maryland Route 100 highway construction site located east of Long Gate Parkway to west of Snowden River Parkway. A penalty of \$10,000 has been assessed. **Status:** A hearing has been requested. A settlement meeting has been scheduled. (Reference #AP-98-0038).

Rockville Fuel and Feed Company, Inc. – Montgomery County

On May 20, 1998, MDE issued an administrative complaint, order and penalty assessment against Rockville Fuel and Feed Company's concrete ready-mix plant located at 14901 Southlawn Lane for violations of the pH and TSS effluent limitations of the facility's State discharge permit. The Order requires a corrective action plan to address treatment improvements necessary to ensure compliance with discharge permit requirements. A penalty of \$50,000has been assessed. Status: The company has requested a meeting to discuss possible settlement terms. (Reference #AO-98-0035).

Sharpsburg Water Treatment Plant – Washington County

On May 12, 1998, MDE and the Washington County Water and Sewer Department signed an administrative consent order requiring improvements to address treatment of filter backwash from the Sharpsburg Water Treatment Plant. The consent order requires that construction of plant improvements be completed by January 31, 1999 to ensure compliance with the TSS and chlorine effluent limitations of the facility's State discharge permit.

Status: Case pending. (Reference #CO-98-0077).

Spurry Family Limited Partnership – Talbot County

On May 21, 1998, MDE signed an administrative consent order with Spurry Family Partnership which settled the October 2, 1996 penalty assessed for water pollution violations. Spurry has agreed to pay a penalty of \$10,000. According to the agreement, Spurry may only discharge wastewater from its seafood processing plant located in McDaniel in compliance with established effluent limitations. Spurry has also agreed to make necessary repairs to the failing septic system serving the facility's restaurant. (Reference #OAH96-MDE-WMA-069-566).

St. Louis Church – Howard County

On June 1, 1998, MDE signed an administrative consent order with St. Louis Church and School which requires that discharges from the church's wastewater treatment plant to waters of the State cease and that wastes be pumped and hauled for offsite disposal until connection to the sanitary sewer system can be completed. The Church has paid a penalty of \$2,500to resolve previous violations of its State discharge permit.

Status: Case Pending. (Reference #CO-98-0023).

Wetland Classroom at Dr. Sally K. Ride Elementary School

The Maryland Department of the Environment, Winchester Homes Inc., and Dr. Sally K. Ride Elementary School entered a cooperative educational effort to educate students about the importance and development of wetlands. Governor Parris N. Glendening has challenged the citizens of Maryland to form partnerships to replace 60,000 acres of wetlands that were lost since the 1940s.

When the Dr. Sally K. Ride Elementary School was developed, wetlands that would have been covered over with concrete were saved. Winchester Homes undertook the wetland creation project at the school to replace wetlands affected by nearby housing development. When the educational project was suggested, plans were changed to increase learning opportunities. First, the wetland grading and planting design was adjusted to include a greater variety of emergent, scrubshrub, and forested wetland areas.



advice on the trail alignment, construction materials, signs and educational materials. Environmental Systems Analysis Inc. researched, designed and constructed the wetland and trail. The company also researched, developed and compiled the interpretive guide and educational package. The recently completed wetland ecosystem and interpretive trail gives students the chance to learn first-hand how wetlands make our lives better.

Then, Winchester Homes agreed to participate in the inclusion of the Dr. Sally K. Ride Interpretive Trail, complete with handicapped access, interpretive signs, species tags, an interpretive guide and in a special water and wetlands educational package.

A committee of school members, Winchester Homes, the environmental consultant, and state and local government agency personnel provided
