P. G. Contractors - Prince George's County - On April 20, 1999, MDE entered into a settlement agreement with this asphalt production facility to resolve air quality permitting violations. The company constructed a new asphalt production plant without obtaining the proper air quality permits. The company has since obtained the required permits. The settlement agreement requires P. G. Contractors to pay a \$15,000 penalty to settle the case.

Status: Case Settled. (Ref # ACP 97-15)

AMG Resources Corporation - Baltimore County - On May 12, 1999, MDE executed an administrative consent order with AMG Resources Corporation in settlement of air pollution stack emission violations. AMG has achieved compliance by upgrading air pollution control equipment at their plant. Under the terms of the consent order, AMG will pay a penalty of \$14,500 to MDE for the stack emission violations.

Status: Case Settled. (Ref # ACP 98-01)

Nucletron Corporation - Howard County - On April 27, 1999, MDE issued an administrative complaint and assessed a \$13,000 administrative penalty against Nucletron, a company that manufactures devices that use sealed sources of radioactive materials. The company violated operational and reporting provisions of its license for the receipt, use and transfer of radioactive materials. Nucletron also manufactured and distributed 45 small medical devices that were not properly described in the application the company submitted for registering the devices with MDE.

Euclid of Virginia, Inc - Baltimore City - A complaint, order and civil penalty for \$12,000 was issued against Euclid of Virginia on April 14, 1999, for violating Maryland oil pollution laws. This action resulted from the company's failure to comply with

the 1998 deadline upgrade requirements on six underground storage tanks (USTs). Four of the six were also out of service and improperly abandoned. There was also an unreported release from a kerosene UST and an improperly abandoned heating oil UST that was not registered with MDE.

Status: Pending (Ref#COV-99-057)

Oil Control Program - The Oil Control Program has entered into its final consent and order for operation of non-compliant underground storage tank systems (USTs). This makes for a total of 35 consents offered and entered into by tank owners who did not achieve compliance with the UST upgrade deadline of December 1998. Owners of non-compliant tanks that are now discovered will face immediate tank closure and possible complaints with penalties issued from MDE.

Jett Patapsco Valley Farm - Baltimore County - On April 23 Baltimore County Circuit Court Judge James Smith has affirmed the department's decision to revoke the Natural Wood Waste Recycling Permit for James F. Jett's Patapsco Valley Farm site and fined Mr. Jett \$50,000 for violations of that permit. Patapsco Valley Farm was the scene of a stump dump fire that took a year to extinguish. Subsequent violations also occurred including improper operation of the facility, illegal dumping and burial of land-clearing debris and another fire in a mulch pile. Mr. Jett has 30 days to appeal to the Court of Special Appeals.

Status: Pending

Dana Transport Systems, Inc., - Baltimore City - MDE is seeking a \$5,000 civil penalty for the Paulsboro, New Jersey based company's failure to have a proper Oil Operations Permit and Oil Transfer License.

Status: Settled (Ref#COV-99-072)

Chredsea, LLC, Cecil County - MDE is seeking a \$5,000 civil penalty for the company's failure to provide financial responsibility documentation on their underground storage tanks located at the Country Market Service Station in Elkton.

Rodney Harbaugh - Frederick County - On May 6, 1999, Administrative Law Judge Georgia B. Powell issued a final decision and order on the

complaint and order issued by MDE to Mr. Harbaugh on February 12, 1999.

The complaint alleged that Mr. Harbaugh's hog farm constituted a Concentrated Animal Feeding Operation (CAFO) and that Mr. Harbaugh failed to obtain a State Discharge permit prior to commencing operation of the farm. Mr. Harbaugh appealed the order to the Office of Administrative Hearings (OAH) on February 25, 1999. Judge Powell upheld MDE's complaint and order requiring Mr. Harbaugh reduce the number of hogs, as well as dairy cows, he maintains on his farm to below 1,000 animal. While Mr. Harbaugh continues to maintain more than 1,000 animal units, he may not land apply or otherwise discharge animal wastes generated by the animals on his property to waters of the State until he obtains a valid State Discharge Permit.

Status: Case Pending. (Ref# OAH Case No. 99-MDE-WMA-067-049).

Brock Steel Compay, Inc., - Allegany County - On May 10, 1999, MDE issued an administrative consent order with Brock Steel Company, Inc., a scrap and salvage facility located at 220 W. King Street, Cumberland, Maryland. The order resolved alleged water pollution violations resulting from unauthorized oily discharges to ground and surface waters of the State. It provides interim authorization to discharge treated storm water until issuance of a State Discharge Permit by MDE. The Order also requires payment of an \$8,000 penalty to the Clean Water Fund.

Status: Settled. (Ref #C0-99-0033).

Highland View Academy and Chesapeake Conference of Seventh Day Adventists - Washington County - On April 29, 1999, MDE issued an administrative consent order with the Chesapeake Conference of Seventh-Day Adventists requiring improvements to the wastewater treatment system at Highland View Academy located in Hagerstown, Maryland. The order requires that a corrective plan and time schedule for further improvements to control wastewater overflows and effluent violations from the plant be submitted to MDE for review and approval within 60 days plus payment of a \$6,500 penalty to the Clean Water Fund in settlement of past water pollution violations.

The order also provides for stipulated penalties in the event of additional wastewater overflows or effluent violations while corrective actions are being implemented.

Status: Settled. (Ref #CO-99-0058).
