Ft. Detrick puts freeze on contaminants

In a remote section of a military base, accessible only via a bumpy dirt road lined with wire fences through cow pastures and woodland, there sits a huge, air-tight canopy tent. Giant vacuums gently suck the air out of the football-field sized structure, and filter it through several layers and types of activated charcoal before releasing the cleaned air into the atmosphere.

Inside the main tent is a 4,000 cubic yard area of dirt surrounded by ice-covered pipes protruding from the ground outlining a tennis-court sized area. Heavy backhoes and specially designed earth movers are staged by men wearing bright yellow 'moon-suits' who are waiting to begin excavating.

In another smaller tent structure — attached to the larger one by an enclosed conveyor belt — is a high-tech laboratory. Here, technicians manipulate rubber gloves behind blast screens to examine and test samples of unknown chemicals to be shuttled in on the belt.

It's not Area 51. It's Area B-11, at Fort Detrick in Frederick, Md. - where the military is excavating chemical waste from the ground that had been buried there between 1955 and 1970.

Fort Detrick officials were aware that chemical waste had been buried in the former landfill, but were uncertain of its scope. In concert with the Army Corps of

Have a merry, 'green' holiday season

Save money and the environment by recycling what you already have at home

As the holidays approach, think of creative ways to make the holiday season environmentally sound. In addition to wishing you a happy and safe holiday season, the Maryland Department of the Environment's (MDE) Waste Management Administration offers some suggestions on how to have more environmentally friendly holidays.

• Make ornaments by recycling CDs. Decorate the shiny side of a CD with glitter glue designs and cover the other side with old wrapping paper or wallpaper. Slip a decorative string through the middle and create a loop for hanging. Or trace small stockings, bells, trees or the like on the shiny side of the CD, cut them out using a small electric saw. Smooth edges, punch a hole in the corner and slide through a string for hanging. Or create a garland by stringing together all the ornaments.

• Make ornaments by recycling film canisters. Poke a hole through the lid and insert a decorative string for hanging. Decorate the canister with glitter glue or beading.

 Make gift containers. Recycle coffee cans, film canisters or cardboard boxes as gift containers. Decorate the containers with old wrapping paper, last year's holiday cards or remnant wallpaper.

• Make new greeting cards or gift cards using old holiday cards. Save the fronts of See GIFTS, Page 5

Businesses are honored for environmental work

Businesses for the Bay, a voluntary program promoting pollution prevention at facilities throughout the Chesapeake Bay watershed, continues to expand its membership and post greater pollution prevention results each year.

With 443 members (109 from Maryland), the program is well on its way to meeting a goal of 1,000 members by 2005. This year, participants reported reducing 22 million pounds of waste, recycling 1.26 billion pounds of materials and conserving over 256 million gallons of water in 2000 at a cost savings of \$15 million. Members also reported having trained 8,124 of their employees in pollution prevention practices.

"Businesses for the Bay is a critical supporting program for reaching the goals of the Chesapeake Bay agreements," said Robert Dunn, of DuPont, chair of the Businesses for the Bay workgroup.

As such, the program seeks to make Businesses for the Bay a household name with a logo recognizable throughout the watershed.

Pollution prevention, or P2, is defined as practices that reduce or eliminate pollution prior to recycling, treatment, or disposal and includes increased efficiency in the use of raw materials, energy, water and the conservation of natural resources. Seventeen organizations were recognized for their successes in these areas at the third annual Businesses for the Bay meeting, which took place Nov. 5 in Hershey, Pa. Five of the winners -Procter and Gamble, Target Corporation, Acme, Struever Bros. Eccles & Rouse and Watercolor Lavender Farm - have facilities in Maryland.

Procter and Gamble is the only threetime Businesses for the Bay award winner. They were honored this year for making further significant reductions in hazardous waste in their nail polish production. By improving their inventory and ordering methods, Proctor and Gamble reduced their nail polish bulk hazardous waste by 307,587 pounds (93 percent), reduced nail polish finish stock hazardous waste by 290,598 pounds (83 percent) and non-hazardous product waste by 2,036,980 pounds (40 percent). By installing speed controls for cooling towers, power factor correction, and frequency drive on 100-horsepower motors, energy use was reduced by 1.5 million kilowatt hours. All employees receive Site Environmental Awareness Training and are asked to focus on waste source/ cost reductions at both work and home.

The Target Corporation's size and

strong market base has allowed them to facilitate changes in the manufacturing industry, particularly in the area of product package reduction. Almost 100 percent of the clothing Target sells arrives without excess packaging. Stores recycle three-quarters of their waste weight and donate non-saleable items to shelters, schools, and humane societies. Target also provides environmental education to store employees including "EcoLogic" a quarterly environmental newsletter. An employee that expends extra efforts in waste reduction is considered an "Eco Hero" and is acknowledged in the newsletter and by having a tree planted in their name in the Chippewa National Forest. Target has implemented better building practices including energy efficiency measures in its new headquarters and several new stores. In 2000, Target incorporated training for its new buyers to increase awareness of recycled content products, as well as how to talk to vendors about environmentally preferable product options.

Albertson's, Inc., the country's second-largest food and drug retailer, and Acme, it's eastern division company, spearheaded development of an unwaxed standard display-ready produce box to replace the waxed corrugated produce boxes that have been the industry standard for decades. Albertson's encouraged and assisted the Fibre Box Association (FBA) to develop an improved corrugated box for shipping produce. The outcome was a corrugated package that provides greater strength and durability and is fully recyclable. The produce box is manufactured from 40-60 percent recycled paper, completing the recycling loop. Albertson's is continuing its efforts by working to replace traditional containers with recyclable packaging in the poultry and seafood industries.

Struever Bros. Eccles & Rouse is a development and construction company that specializes in the adaptive reuse of underutilized and/or historic sites. In 2000, Struever Brothers focused on redeveloping Tide Point, a former soap-making plant in Baltimore. Tide Point is now a mixed-use, urban campus and a prime example of the intent of Maryland's Smart Growth Program. The project is located in an Enterprise Zone Priority Funding Area in Baltimore City and is also considered a "brownfield."

Green space was sprinkled throughout various elevations of the landscape to help control runoff to Baltimore Harbor. Streuver Bros. has opened its office there and participates in the Maryland Department of Housing and Community Development's Live Near Your Work Program.

Jo Asher and her family run Watercolor Lavender Farm, Maryland's first lavender farm. To halt the runoff of soil to a nearby stream, they planted grass in all areas plowed by previous owners and installed a fence to prevent horses from reaching the stream. They also created stream buffers averaging 100 feet and set aside acreage for wild-


MDE honors Kiwanis Builder's Club for contributions

life habitat. To minimize erosion, lavender is planted between 6-foot grass strips. Only the planting areas are plowed and the plants are double cropped. The farm does not use pesticides on the lavender and only a small portion of the farm receives targeted herbicide applications in the lavender strips. The lavender products produced on the farm all carry the motto: "We are all the keepers of the lighthouse. The light of the decisions we make today will grant the Chesapeake safe passage into the future." Proceeds from some of the lavender products go to non-profit organizations.

A leadership award was also presented at the annual meeting to Steve Farkas, who served as the *Businesses for the Bay* Workgroup Chairman from 1996-2001 while representing Baltimore Gas and Electric. Farkas also received *Businesses for the Bay's* first Mentor of the Year in 1997.

This column is focused on questions concerning business environmental compliance issues. Since many questions may require more space than is available to answer fully, these answers will often provide contact information for more detailed information. Please submit questions to Maryland Department of the Environment, EPSC - Ask MDE, 2500 Broening Highway, Baltimore, Md. 21224. You may also questions e-mail to EPSC@mde.state.md.us with Ask MDE in the subject line. It is not necessary to identify yourself or your business. Questions that are of general interest will be answered in this column.

Q. I just purchased an existing dry cleaning store. What do I need to do for MDE?

A. Most dry cleaners have to deal with air quality and hazardous waste issues. Both of these programs involve notification and record keeping requirements. When purchasing a new store the owner information for both of these must be updated and it is also a good idea to check the existing records. Be sure to keep copies of what is sent to the department. Ideally, you should make sure the owner has the required permits and paperwork before you buy the business.

To update the owner information for the air quality permit use the form for the Air Quality General Permit to Construct for Perchloroethylene Dry Cleaning Equipment. Write "Registration" at the top of the form and send it to MDE, attention ARMA Data Management. There is no fee for the registration update, however, if there are any changes to the location or equipment, you will need a new permit and will have to pay a \$500 permit fee. For additional assistance in completing the form contact the Small Business Assistance Program at (410) 631-3772 or the Air Quality Compliance Program at (410) 631-3220.

To update the EPA hazardous waste identification number you will need to use form 8700-12 Notification of Regulated Waste Activity that is available from MDE or its website, www.mde.state.md.us. When you are submitting this update be sure to mark the box for subsequent notification in section I and the change of owner indicator in section VII.D. Please note that for subsequent notifications you are required to complete sections I, II, IV, VI, VII, IX and X. You are also required to complete any other **See ASK, Page 4**

information that may have changed, such as section V, Installation Contact. Contact the hazardous waste program at (410) 631-3344 or the Environmental Permits Service Center (EPSC) at (410) 631-3772 if you need assistance completing the form.

Also check the record keeping from the previous owner. You do not want to be in the position of having problems during an inspection because the previous owner did not keep proper records. If problems with the records are discovered, disclose these problems in writing to MDE, along with the procedures you will use to prevent these problems re-occurring under your ownership. By taking these steps you may be able to put these issues behind you before an inspector shows up.

The EPSC can provide assistance with these and other environmental transfer of ownership issues. The department also has a Small Business Pollution Compliance Loan Program that may be able to finance an upgrade to your existing dry cleaning machines.

Although the information provided in this column is generally accurate for the specific situations that are addressed, it is not a substitute for compliance with any requirements. Due to the complex nature of environmental regulations, call the Maryland Department of the Environment through the Environmental Permits Service Center with any questions about the permit or how the regulations may apply to a specific situation.

greeting cards you receive and use them to make new cards or gift tags. To make new cards, paste the picture on a folded piece of construction paper. In the inside paste a sheet of folded writing paper for your greeting. Or make the fronts of cards into new greeting postcards by drawing lines for address and saving space for the stamp.

• Make gift bags. Decorate brown paper bags with old wrapping paper or wallpaper remnants and use as gift bags.

• Recycle your natural Christmas tree. Consult your county recycling coordinator about grinding the tree limbs and trunk into mulch. Before sending the tree for mulching, place it near a bird feeder to provide shelter to birds.

• **Reduce your use of materials**. Use old newspapers or brown paper to cover packages. Write a greeting and "gift tag" right on the package. Or use gift bags that can be reused year after year. Or reuse pieces of large gift-wrap from the previous year.

• Buy recycled content products whenever possible. Greeting cards, gift-wrap and journals of recycled material are easy to find. Also buy rechargeable batteries in place of standard batteries for toys and cameras.

• **Recycle electronics**. Recycle your old computers and televisions as you replace them with new gifts.

Engineers and the Army Environmental Center, Fort Detrick staff began excavating the site in 1997 with a backhoe and personnel in breathing apparatus.

In short order, the crew found beakers, drums and other evidence of waste chemicals.

"It was so bad," said Lt. Col. Jeffrey Springer, chief of Fort Detrick's Safety, Environmental and Integrated Planning Office, "we decided to stop because of the danger [to personnel and the environment]."

Continued excavation of the buried chemicals without some sort of barrier beneath them would likely increase groundwater contamination, so Fort Detrick was faced with an interesting problem. They elected to create a barrier of frozen soil beneath the buried waste. Using sophisticated pipe structures tunneling into the ground in a tennis court sized "V" beneath the waste pit, the soil will be frozen all the way down to the bedrock – a depth of about 35 feet. The deepest part of the chemical waste pit is about 18 feet. This barrier will prevent any migration of contaminants into the groundwater.

The vapors released in the 1997 test trenching also led the Army to install the huge containment structure over the entire work site. Louvers on one end of the structure allow air to flow in, while eight large fans pull the air out of the other end and into one-micron particulate filters and activated carbon to remove dust and volatile organics. The filtration system is designed to change the entire volume of the air inside the containment structure every four hours.

The actual excavation work began in early November. Soil and chemicals are being excavated slowly so as to prevent spillage and chemical release. The material is being sifted for chemical containers, which will be analyzed in the attached laboratory to determine contents. The remaining material, which according to Army staff includes "anything smaller than a mayonnaise jar," will be shredded and spread out and dried to ensure there are no chemical reactions. All material ultimately will be disposed of in a hazardous waste facility in Canada.

The \$4.8 million environmental restoration project also includes a series of other safety features such as blast shields, safety screens and foam suppression units.

Air & Radiation Management Administration

United Energy Coal, Allegany County – MDE entered into a Consent Order with the United Energy Coal Company on Oct. 22. United Energy operates a coal processing facility just outside of Frostburg that had been cited by MDE inspectors for failing to control dust and creating a nuisance. Under the terms of the Consent Agreement, United Energy agrees to take extensive corrective action to reduce dust emissions and also agrees to pay a \$7,500 penalty. **Status:** Case closed. (Reference #AQCP 01-02-01)

The Berg Corporation, Frederick County – MDE issued a Notice of Proposed Civil Penalty to The Berg Corporation on Oct. 29 for installing and operating a concrete crushing and screening plant at a construction site in Frederick County without first obtaining an air quality permit to construct and permit to operate. The violation was discovered during an MDE inspection of the facility. The proposed penalty amount is for \$3,500. Berg has 10 days to request a meeting to discuss the proposed penalty. **Status:** Open (Reference #AQCP 01-17)

Amcor Flexible Packaging, Washington County - MDE issued a Corrective Order and a Notice of Proposed Civil Penalty to Amcor on Oct. 30 for violations of air quality regulations at its flexible packaging plant. The company was cited for not notifying the department in a timely manner of a change of ownership, for not conducting required testing, and for not submitting certain reports required by its permits. The order requires the company to submit a plan within 30 days to address all violations cited. The proposed penalty amount is for \$35,000. Amcor has 10 days to appeal the order and request a meeting on the penalty. Status: Open (Reference #AQCP 01-09-01)

Dave's Tree Service, St. Mary's County – MDE issued a Corrective Order and a Notice of Proposed Civil Penalty to Dave's Tree Service on Oct. 30 to address open burning violations. Dave's Tree Service has been cited numerous times by MDE and the St. Mary's County Health Department for open burning violations including burning without a permit, creating a nuisance, and burning off-site materials. The order requires Dave's Tree Service to submit a plan within 30 days to address all violations cited. The Proposed Penalty amount is for \$5,000. Dave's Tree Service has 10 days to appeal the order and request a meeting on the penalty. **Status:** Open (Reference #AQCP 01-08-01)

Lesaffre (formerly Red Star Yeast), Baltimore City - MDE entered into a Consent Order with Lesaffre on Nov. 6 to resolve air quality violations. The facility failed to perform and document calibrations of monitoring equipment, and failed to conduct manual sampling of the air stream when the on-line monitor was out of service. The Consent Order requires the company to pay a penalty of \$10,000 and to take corrective actions to prevent similar occurrences in the future. MDE's action was initiated as a result of information contained in a required Quarterly Report. Status: Case closed. (Reference #AQCP CO-01-11-01)

Helping Hands Veterinary Clinic, Frederick County - MDE issued a Notice of Proposed Civil Penalty to Helping Hands Veterinary Clinic on Nov. 15 for operating an illegal incinerator without a permit. MDE inspected the facility and observed the operation of an unpermitted incinerator. MDE reviewed Helping Hands' permit application and determined that the incinerator could not meet Maryland's technical requirements and denied the permit application. Frederick County also denied operation of the incinerator on zoning grounds. The proposed penalty is in the amount of \$5,000. Helping Hands has 10 days to request a meeting to discuss the proposed penalty. Status: Open (Reference #AQCP 01-16)

Davis Concrete, Harford County – MDE issued a Corrective Order and a Notice of Proposed Civil Penalty to Davis Concrete on Nov. 15 for violations of air quality regulations at its Harford County cement production plant. The company was cited for failure to control dust and creating an air pollution nuisance. The order requires the company to submit a plan within 30 days to address all violations cited. The proposed penalty amount is for \$28,000. Davis has 10 days to appeal the order and request a meeting on the penalty. **Status:** Open (Reference #AQCP 01-08-02)

Water Management Administration

Town of Centreville, Queen Anne's County – MDE and the Town of Centreville entered into a Consent Order on Oct. 30, regarding biological nutrient removal (BNR) and upgrades to expand treatment capacity at the Centreville Wastewater Treatment Plant. The conditions of the Consent Order anticipate that the upgrades will be completed by Dec. 31, 2002. The Consent Order allows for interim performance standards for total suspended solids, biochemical oxygen demand and total phosphorus. **Status:** Case Closed (Reference # CO-02-0041)

Interstate Corrpack, Inc., Dorchester County – MDE entered into a Settlement Agreement with Interstate Corrpack on Oct. 29, to resolve alleged violations of the facility's pretreatment agreement with the city of Cambridge. The Settlement Agreement requires Interstate Corrpack to pay \$25,000 to the Clean Water Fund in resolution of ink discharges to the Cambridge Wastewater Treatment Plant. Bowley's Quarters Condo Marina, Baltimore County - MDE entered into a Consent Order with Bowley's Quarters Condo Marina on Oct. 24 to resolve effluent limit and monitoring violations of the facility's National Pollutant Discharge Elimination Process (NPDES) discharge permit. The terms of the Consent Order require the facility to comply with its NPDES permit. If the facility has any additional effluent limit violations, it must supply a plan and schedule for upgrades to ensure compliance with the NPDES permit. The facility is required to pay \$1,000 to the Clean Water Fund in resolution of the effluent limit violations. In addition, MDE is holding \$4,000 in abeyance to be paid if the facility does not complete all requirements of the Consent Order. Status: Case Closed (Reference # CO-02-0014)

Weems Creek Medical Center, Anne Arundel County – MDE entered into a Consent Order with the Weems Creek Medical Center on Oct. 16, regarding future connection to the Anne Arundel County sanitary sewer system and to cease operation of the current septic system. The terms of the Consent Order require the facility to pump and haul sewage to an approved permitted, off-site disposal site until the facility can be connected to the county sewer system, an alternative on-site wastewater treatment system is constructed, or holding tank(s) can be installed. In addition, the owner of the facility is required to establish an escrow account in the amount of \$10,000, which will be used to reimburse part or all of the costs incurred by nearby private residential property owners, for the installation of new and deeper wells on their properties. Any money remaining in the escrow account after Oct. 16, 2003 shall be paid to the Maryland Clean Water Fund. Status: Case Closed (Reference # CO-02-0068)

J & V Investment Company, Worcester County – MDE entered into a Settlement Agreement with J & V Investment on Oct. 15 to resolve alleged sediment control and sediment pollution violations referenced in Administrative Complaint and Penalty # AP-01-0209 by the payment of \$5,000 to the Sediment Fund. 
