Trash removal system will help clean Anacostia

Lt. Governor announces new P.G. County project

Continuing its growing commitment to preserving the Chesapeake Bay and its tributaries, the Maryland Department of the Environment (MDE) will install devices along the Anacostia River in Prince George's County to filter trash from the

water, Lt. Governor Kathleen Kennedy Townsend announced recently.

"Recent estimates from the Metropolitan Washington Council of Governments (MWCOG) indicate that 20,000 tons of trash enters the Anacostia River annually, and this cycle has gone on for too long," the Lt. Governor told the crowd gathered at the new Ropewalk Pavilion in Bladensburg Waterfront Park. "Our resolve is to eliminate and prevent this persistent

Judges' rulings lead to safer housing for kids

Property owners and renters alike should take note of two significant rulings recently made in Maryland's court system. The decisions demonstrate the state's increased efforts in lead poisoning prevention.

On June 21, the Maryland Department of the Environment (MDE) executed a settlement agreement that will result in lead hazard reduction treatments being performed on a minimum of 480 rental properties in Baltimore City over the next two years.

The settlement is with 87 separate corporate and partnership entities, of which Stanley Rochkind, of Baltimore, has a controlling interest, including S&S Partnership and others overseen by Dear Management. Rochkind-controlled entities together own more than 700 occupied pre-1950 rental properties, making them one of the largest landlords in Baltimore City.

The conglomerate also agreed to pay a \$90,000 penalty, of which \$40,000 will be held in an escrow account and may be reimbursed, if they comply with requirements to perform the 480 full risk reduction treatments.

EPA honors MDE's Larry Morgan

Inspector is considered among best in the nation

More than two months after being awarded as the U.S. Environmental Protection Agency's (EPA) first ever regional Inspector of the Year, Maryland Department of the Environment (MDE) Inspector Larry Morgan is still in a state of shock.

"I was surprised because I didn't know anything about it," Morgan, an MDE Oil Control Program inspector said. "I didn't even know they had such a thing. I never knew anything about it. I think everyone is surprised because it's something you do

every day."

Morgan, who was nominated by his peers, was chosen from candidates throughout the state environmental agencies in Delaware, Maryland, Pennsylvania, Virginia, West Virginia and the District of Columbia.

"Larry demonstrates what is best about this agency, its people," said MDE

Make home improvement projects safely

For most the summer season conjures images of getting away from the daily routines of work and school, taking vacations and living a life of leisure, travel and adventure, if only for a short while. But for many homeowners and do-it-yourselfers, the warm weather is also the time for projects around the house.

And while it is easy to get caught up in the momentum of getting all of the projects finished, it is useful to know that a few summertime projects can affect the health of those involved and can introduce pollutants into the air.

Projects around the house can range from reducing clutter in the garage or basement to remodeling the house. Many people either perform or have work done on their home during the summer because several projects done in the home, such as painting or installing new carpet, require good ventilation. Good ventilation means allowing outdoor (ambient) air to pass through the house to remove vapors and odors produced when painting or remodeling.

Painting is an excellent way to change and improve the appearance of a single room or an entire house. Some painting is basic maintenance that is needed to protect surfaces from moisture and extensive use. But there are important things to keep in mind when choosing paints and painting. Oil-based paints release high amounts of volatile organic compounds (VOCs) and these vapors are harmful to breathe and also contribute to the formation of ozone air pollution. Consider using paints with lower amounts of VOCs. Alkyd-based paints and latex paints are much safer, but do release some VOCs into the air. Even the low amounts of VOCs bother some people, so when working indoors, be certain that ventilation is adequate.

Another way to change and improve the appearance of a home is to refinish wood floors or replace carpeting. Staining and finishing

are the steps that help beautify floors and show all the wood's character but remember to handle these products with caution and work in a well-ventilated area — since many wood-finishing products produce harmful vapors.

Since most carpets, furniture and cabinets are often treated with formaldehyde, that "new" smell most people enjoy around the house is likely newly introduced VOCs. Formaldehyde, used to prevent mildew and improve colorfastness of dyes, has a distinct odor and can cause respiratory irritation. If possible, let new products "air out" before bringing them inside and keep the house well ventilated for several days after installing new products in the home.

Owners of older homes should make extra considerations for any possible asbestos or lead paint that may have been used in the dwelling during its construction and care should be taken when working around these substances. Asbestos is most commonly found in pipe and furnace insulation materials, asbestos shingles, millboard, coating materials and floor tiles. Elevated concentrations of airborne asbestos can occur after

cutting, sanding or other remodeling activities disturb any household materials that contain the chemical. Improper attempts to alter or remove these materials can release high levels of asbestos fibers into the indoor air, endangering the people living in those homes. Lead paint that is chipping is also dangerous — especially to small children who are susceptible to poisoning — to anyone who swallows or breathes it. When scraping or sanding old paint, be certain to wear a dust mask and to sweep up the chips and wipe up the dust with a damp rag.

When cleaning out the garage or other storage areas, never pour excess paint (even latex paints), solvents, or other household cleaning products down the drain. The safest way to dispose of alkyd-based and latex paints is to leave them in their cans, set them outside with their lids off and let them dry completely.

Then take the cans and other

MRAS is program's first 'Member of the Month'

The Businesses for the Bay Member of the Month is a new feature of the *MDE Environment* that will recognize some of Maryland's participants in the voluntary pollution prevention (P2) recognition program.

This month's member, Middle River Aircraft Systems (MRAS), generously agreed to serve as the site for a pollution prevention training program held in May for the Maryland Department of Environment (MDE) hazardous waste enforcement program.

MDE staff members reviewed pollution prevention techniques and then explored opportunities at MRAS.

MRAS designs, manufactures and services complex aerostructures, including large engine thrust reversers, for commercial and military jets. They

strive to meet a hazardous waste reduction goal of 10 percent annually. To achieve this, MRAS has worked to

extend the bath life of its chromate plating tanks and has instituted 'spot anodizing' to avoid filling a whole tank for a small number of parts. In just the last four years MRAS has been able to reduce solid waste production by 25 percent through informed purchasing decisions.

In 2000, MRAS recycled 51 tons of paper and cardboard, 280 tons of scrap metal, 20 tons of wood and pallets, 31 tons of plastic media, and 200 tons of oil. MRAS has also put in place new spill prevention equipment and an ongoing program to evaluate and implement pollution prevention opportunities.

Maryland, Thailand work together to improve environment

Asian/Pacific American History Month took on greater meaning as the Maryland Department of the Environment (MDE) hosted four delegations of environmental protection staff from Thailand during May.

The first two delegations came to MDE as part of the on-going Chiang Mai Air Quality Initiative. This initiative, sponsored by the Council of State Governments and the United States-Asia Environmental Partnership focuses on building the capacity of Thai federal and local air quality protection staff and developing an Air Quality Management Plan for Chiang Mai, Thailand's second largest city. The other delegations visited Maryland because of its growing international reputation for environmental protection excellence and as a result of the U.S. Environmental Protection Agency's partnership with the Thai Ministry of Science, Technology, and the Environment.

"Our partnership with Thailand illustrates the important value of thinking and acting globally on environmental protection," said MDE Secretary Jane T. Nishida.

The first delegation consisted of two staff from the Thai federal Pollution Control Department (PCD) and two staff from the Chiang Mai municipality. The delegation participated in a two-week training with their MDE colleagues focusing on air quality control technology and regulation development. The topics reviewed included: A thorough review of control technologies (including the terms "best available" and "reasonably available," cost effectiveness, how to choose which sectors to select), writing regulations, permitting, enforcement and compliance, use of voluntary programs, continuous emissions monitoring, and the role of outreach and education in a successful pollution control program.

Immediately following the training group's departure, a second delegation came to MDE.

This senior staff study group was led by Manut Sirimaharaj, the Chiang Mai municipality's deputy mayor for Public Health and the Environment and Dr. Supat Wangwongwatana, director of PCD's Air Quality and Noise Division. The primary focus of the week-long visit was a series of air quality policy discussions and briefings with Secretary Nishida, MDE Air & Radiation Management Administration Director Ann Marie DeBiase, and various MDE program managers and staff. A number of site visits to facilities utilizing air quality control technology to protect the environment were also completed.

Commenting on the value of the delegation visits, DeBiase said, "It's interesting. By working with the Thai government, we are giving them information they need, but we also profit from the visits. Every time a delegation from Thailand visits, the exchange of ideas is excellent. Those of us fortunate enough to work

with the delegations find ourselves in the enviable position of being both teacher and student."

The delegation also visited EPA to learn about the respective roles of federal and state governments in the U.S., how they work together to protect and improve air quality, and to discuss EPA's Green Fleets Program and their fuel quality and on-board vehicle diagnostics activities. The visit gave the delegation a better understanding of air quality protection activities in the United States as well as numerous ideas of how to address Chiang Mai's air quality challenges.

During his visit, Dr. Supat gave a brown bag lunch lecture on "Activities and Programs to Improve Bangkok's Air Quality" to MDE staff as part of Asian/Pacific American History Month.

State, fed projects get new stormwater management regs

Maryland Department of the Environment's (MDE) Water Management Administration is publishing new guidelines for the design of state and federal stormwater management construction projects.

The purpose of these guidelines is to protect, maintain and enhance the public health, safety and general welfare by establishing minimum requirements and procedures to control the adverse impacts associated with increased stormwater runoff.

By improving design standards and providing environmental incentives, MDE hopes to produce better methods and advance the science of managing stormwater by relying less on single best management practices (BMPs) and more on mimicking existing hydrology through total site design policies.

Additionally, the inherent philosophical change should produce smaller, less obtrusive facilities that are more aesthetic and less

burdensome on those responsible for long-term maintenance and performance, according to Jim Tracy, chief of MDE's Sediment and Stormwater Plan Review Division.

Research indicates that proper management of stormwater runoff will minimize damage to public and private property, reduce the effects of development on land, control stream channel erosion, pollution and sediment deposition, reduce local flooding, and aims to maintain and/or improve the pre-development runoff characteristics.

These guidelines, which supplement the Stormwater Management Regulations and the "2000 Maryland Stormwater Design Manual," provide information necessary for submittal of stormwater management plans by state and federal agencies to MDE for review and approval.

These guidelines include specific instructions for provisions of exemptions (e.g., agricultural land management practices, etc.), waivers (e.g., the project shall return the dis-

turbed area to a predeveloped runoff condition, etc.) and encourage the development of Institution/Agency Management Plans, as well as define procedures for new and redevelopment projects using environmentally sensitive design measures.

MDE encourages wise, environmentally sensitive site designs to reduce the generation of runoff borne pollution. These guidelines and locally implemented stormwater management ordinances establish a new beginning for the treatment of stormwater runoff from impervious areas across the state of Maryland.

Q. I recently heard my company is required to submit a list of chemicals we use to MDE and some sort of local committee. What's this all about?

A. MDE works with counties, localities and the Maryland Occupational Safety and Health (MOSH) to implement programs regarding right-to-know information. There are two laws — one federal and one state — which support three separate routine reporting requirements. The federal program, the Emergency Planning and Community Right-to-Know Act (EPCRA), covers emergency planning, emergency release notifications, hazardous chemical storage and toxic chemical release reporting. At the state level, Employee Right-to-Know covers information for employees about the chemicals found in their workplace.

EPCRA is also known as SARA Title III, a law requiring several different but related notifications and filings. The Extremely Hazardous Substance (EHS) Notification — typically a letter that does not require the name or quantity of the substance — is required for companies that meet or exceed the threshold amount for an EHS.

Facilities that store 10,000 pounds or more of a hazardous substance, are required to provide a list of the substances or the material safety data sheets to the State Emergency Response Commission (SERC), Local Emergency Planning Committee (LEPC), and the local fire department as well as to MDE. For an EHS, the

Volunteers, agencies build scrap tire playground

Yesterday's throwaways were turned into wonder and delight June 7-9, as volunteers and workers from several Maryland state agencies joined forces to construct a scrap tire playground in the Milburn Landing Area of Pocomoke River State Park in Worcester County.

Representatives from the Maryland Department of the Environment

(MDE) and Natural Resources, the Maryland Conservation Corps and Maryland Environmental Services, along with 150 community volunteers used the weekend to turn scrap tires into a source of amusement at the lower Eastern Shore park.

The volunteers, who have varying skill levels, did not rely solely on whole scrap tires collected from throughout the state, but utilized recycled plastics, tire mats and "plastic" lumber to get the job done.

The new playground overlooks the Pocomoke River near the park's rentable cabins, campground and picnic pavilion. Amongst its lively features are a swamp monster, a zip line, tire swings, chimes made of metal pipe and a two-part pirate ship complete with slides and a gang plank.



"We build one of these special playgrounds every year," said Abigail W. Pascual, a project manager in MDE's Scrap Tire Program. "It's really rewarding to do something good for the community ... and

also to raise awareness about scrap tires."

Scrap tire dumps pose a risk to public and environmental health. Tire fires can generate thick,

black noxious odors and produce oil from the melting tires, which can pollute soils, ground and surface waters. In warmer months following rain, scrap tires become breeding grounds for mosquitos.

The \$62,000 project, funded by the Maryland Used Tire and Recycling Fund, was scheduled to coincide with Earth Day 2001 in April, but was postponed. Yet, Pascual said the delay did not seem to affect the outpouring of support the event received — especially from city and county officials.

"They hope this playground will increase the use of the park," Pascual said.

The scrap tire playground at Pocomoke River State Park, designed by the New Hampshire-based Learning Structure Inc., is the ninth facility of its kind built since the program began in 1992.

Secretary Jane T. Nishida. "I am very proud to say he is indicative of the employees that make Maryland a leader in environmental stewardship and protection. He does outstanding work and is an invaluable asset to the department and the citizens of Maryland."

"Larry Morgan's work at MDE has had a direct effect on protecting Maryland's land and water resources," added Thomas C. Voltaggio, acting regional administrator of the EPA. "His commitment to environmental protection serves as an example to all of us."

Morgan, who had been working on petroleum outlets, began his career with the department 14 years ago after a routine encounter with an MDE inspector, who suggested he apply for a vacant position.

"I was working in the petroleum industry and ran into a state worker at a site," Morgan said. "It all ties together."

His employment with the state allowed the Oakland resident the opportunity to do something he never thought he'd do — return to college. In 1993 he enrolled at West Virginia University, where he divided his time between work at MDE, his family and 15 credits a semester, to earn his degree in resource management and economics.

According to his supervisors, it is not surprising that the EPA chose Morgan to honor at their April 17 meeting in Avalon, N.J.

"He won this award because of his hard work and dedication to the program and the citizens of Maryland," said Rick Lego, a regional manager in MDE's Oil Control Pro-

gram. "These inspectors make decisions that are almost on their own. They have a tremendous responsibility over what course of action to take to help bring people into compliance."

Herb Meade, chief of compliance and remediation in the Oil Control Program, agreed with Lego's assessment of the demands facing an inspector.

"Larry has been able to demonstrate an ability to prioritize his region of responsibilities," Meade said. "He's out in the far reaches of Western Maryland ... So he's out there on an individual basis."

Throughout his MDE career, Morgan has displayed skills in inspecting facilities throughout the state's western region, yet the honor from EPA has not been his first achievement. He was the first Maryland state

environmental inspector to gain 100 percent compliance in the 1998 upgrades for underground storage tanks — removing significant threats to groundwater storage tanks and surface mining activities.

Still, Morgan insists it is his support team at MDE that has allowed him to accomplish so much during his 14 years with the department. "I don't look at it as something I did," he went on to say. "I look at it as something the whole division has accomplished."

Editor's Note: MDE sadly reports that Larry Morgan died unexpectedly July 2, prior to the publishing of this article. Supportive thoughts and prayers go out to his family. He will be remembered as someone dedicated to the agency's mission.

Following the senior staff study group's visit, MDE hosted an eight-person delegation focussed on water quality issues. This delegation, which visited MDE for three days before heading to Athens, Georgia to meet

with EPA staff for two days, was led by Nisakorn Kositratana, PCD's deputy director general, and Samorn Mutamara, associate professor of environmental engineering at the Asian Institute of Technology.

The delegation was interested in the Chesapeake Bay restoration and protection activities; permitting and compliance programs; pretreatment and pollution prevention activities; the Total Maximum Daily

Load program; and water quality monitoring and modeling activities work individually and how they all fit together to enable MDE to address our water quality protec-

and expensive blight from deteriorating Maryland's environment."

The two trash racks, which will be installed in the Anacostia River pumphouses located at the newly renovated park, will remove trash and floatable debris from the water as it enters the pumps.

The first of the racks, which is currently being fabricated, will be installed in the Colmar Manor pumphouse across the river from the park shortly after its expected delivery in mid-June. The second unit, which will be installed in the Bladensburg pumphouse on park grounds, is slated for delivery in late fall. Both pumphouses are currently under construction to modify them for the trash rack installation. The sites for the racks were identified by MDE in a partnership with the Prince George's County Department of Environmental Resources.

Maryland's Lt. Governor made the announcement at an event sponsored by the Bladensburg Town Council to express the appreciation of both lawmakers and residents for the state's efforts and support to renovate the town's park as well as the Anacostia River. Lt. Governor Townsend was joined by Washington DC Mayor Anthony Williams, Congressman Albert Wynn and oth-

ers involved in the Anacostia watershed. She was also joined by her mother, Mrs. Ethel Kennedy, who has been working on the Anacostia River project as a long-time board member of the Earth Conservation Corps and

the Mayor's Environmental Council.

The state's commitment to assisting the town of Bladensburg and the Anacostia watershed is not new. Efforts intensified in 1994, when officials from the port towns of

Bladensburg, Colmar Manor and Cottage City began working to revitalize this environmentally sensitive area.

After a December 1999 letter from Robert Boone of the Anacostia Watershed Society asked the state to "take responsibility for the floating debris originating within its borders," Lt. Governor Townsend asked Governor Parris N. Glendening to include an additional \$275,000 in the budget for MDE to initiate a pilot trash reduction system. Recognizing a potentially good way to solve a chronic pollution problem, the funding for the project was then matched by Prince George's County.

With the first phase of renovations to Bladensburg Waterfront Park finally complete, officials from the Port Towns used today's ceremony as a way to thank the State of Maryland, Prince George's County and the other long-time partners for their commitment to the project.

"Without the help of our state, federal and local officials, these renovations would never be taking place," said Bladensburg Town Councilwoman Marion Hoffman, hostess of the event. "The people of Maryland should take comfort knowing that our elected leaders really do care about protecting and preserving the state's natural resources."

The settlement resolves hundreds of potential claims that could have been brought by MDE for violations of the state lead paint law. It also resolves a May 4 Proposed Decision issued by Administrative Law Judge Stephen Nichols in an enforcement action brought by MDE against S&S Partnership, assessing the statutory maximum penalty of \$100,000 for failure to bring a Baltimore City rental property into compliance with state lead hazard reduction standards.

"A few weeks ago, we had 755 properties under voluntary consent order for compliance," MDE Secretary Jane T. Nishida said. "With this global settlement, we will now have more than 1,250 properties that will be brought into compliance. These enforcement settlements are the direct result of the Governor's Lead Initiative and emphasize our message to landlords not to ignore the hazards of lead paint poisoning and the role they play in reducing that risk.

MDE is continuing to focus its resources to vigorously enforce lead laws."

In the S&S Partnership case, the judge assessed the maximum penalty after hearing evidence that showed S&S failed to have a rental property in the 3800 block of Belle Avenue properly inspected for lead risks and 3,900 Maryland children were reported to have elevated blood lead levels equal to or greater than 10 micrograms per deciliter.

Throughout the year, MDE's Lead Poisoning Prevention Program assists local health departments with case management of lead poisoned children and coordinates locally based outreach and education campaigns.

unwanted household products to an approved disposal site in your community.

Don't forget, summer is the time to enjoy the outdoors and perform lawn maintenance, which becomes a regular activity from spring through autumn, especially if the region receives normal rainfall. However, certain practices can be harmful to the environment. Nitrogen oxides from gasoline-powered lawn equipment contribute to the formation of ground-level ozone. On days when ozone is forecasted to be at un-

healthful levels, do not use gasoline-powered lawn equipment.

quantity that triggers these reporting requirements is either 500 pounds or the threshold planning quantity (TPQ), whichever is lower. These lists need to be updated whenever there are significant changes at the facility. If your facility meets this requirement then you must also complete an annual inventory (Tier II). The annual inventory needs to include quantity, location and storage conditions for these substances. These inventories are due by March 1 and must be submitted to the same organizations as the original lists. EPCRA also contains requirements for accidental release reporting.

For more information on how to comply with these requirements please contact MDE at (410) 631-3800. Additional information, the list of EHSs and their threshold planning quantities (TPQ), blank reporting forms, and EPA guidance documents can be found at www.epa.gov/swercepp/crck.html.

The Toxics Release Inventory, or TRI, is also part of EPCRA. Under TRI certain facilities (mainly manufacturers) are required to report on their activities with listed substances if they exceed established thresholds. TRI is an annual reporting requirement with reports due to EPA and MDE on July 1 each year. For more informa-

tion about TRI, contact the Community Right-To-Know Section at (410) 631-3800. Additional information, the list of TRI chemicals and thresholds, reporting forms and instructions, EPA guidance documents, and access to TRI data can be found at www.epa.gov/tri/.

MOSH administers and enforces employee right-to-know laws. MDE's responsibility is to collect the Chemical Information list that is required as part of the law. All employers in the state with one or more employees must file a chemical information list with MDE. Unlike the components of the federal right-to-know program there is no threshold for the quantity of the chemicals to be included in the state right-to-know list. Information on how to comply with these regulations is available through MOSH at (410) 880-4970.

Although the information provided in this column is generally accurate for the specific situations that are addressed, it is not a substitute for compliance with any requirements. Due to the complex nature of environmental regulations, you should call the Maryland Department of the Environment's Environmental Permits Service Center if you have any questions about your permit or how the regulations may apply to your situation.

Mettiki Coal, Garrett County — MDE entered into a Consent Decree with Mettiki Coal on May 11 to address violations at its coal mining and processing facility located in Garrett County. Shore program collects 39 tons of household hazardous waste

In response to a rapidly growing need on the Eastern Shore to have household hazardous waste collection, the Maryland Department of the Environment (MDE) worked to create a household hazardous waste (HHW) collection program.

On a regular and sometimes daily basis, citizens were calling MDE's Centreville Regional Office, the Midshore County Recycling offices and the Midshore Landfill asking, "Where can we take old paint, pesticides, fuels, etc.?"

When they were told there were no special services offered by the state or counties at that time, they expressed frustration, anger and confusion. Citizens wanted to do the right thing—protect the environment and properly dispose of their unwanted household hazardous waste.

James Wood, recycling coordinator for the Midshore Recycling Program, Bill Schmidt, MDE's Eastern Shore regional manager, Maryland Environmental Service (MES) and other midshore county representatives moved forward on the problem and organized a regional HHW workgroup to explore the feasibility of a HHW collection program for midshore citizens.

A pilot HHW collection program became a reality in September 1998, when the Midshore Recycling Program received

a \$38,000 grant from the Alliance for the Chesapeake Bay and the U.S. Environmental Protection Agency's Watershed Grant Program.

Nearly four years later, the program is thriving as Midshore HHW collection events are held in the spring and fall each year. The events are now jointly funded by each of the Midshore counties—Caroline, Kent, Queen Anne's and Talbot.

And while Woods is credited for establishing the HHW collection program in the region, he insists it was not a one man project.

"It's been a real team effort with MDE at the table every step of the way along with other regional, county and MES staff," Woods explained. "There were three factors that led to the development of this program: the need, that came from people; the means, that came from a service contract developed by MES; and the funding, that came from the original EPA grant."

Since its inception in 1998, the Midshore HHW Collection has held a total of six events. The events have served a total of 1,121 participants and collected about 39 tons of HHW.

Wood and the other regional workgroup members are hopeful that the counties will continue funding the successful program.

"This is the greatest thing since sliced

bread," said Bill Torey of St. Michael's, one of the many citizens who has participated in the HHW events. "We can now clean out our garages of unwanted, dangerous chemicals."

"If you want to see happy people who are appreciative of a local government service, just come to a Midshore Household Hazardous Waste event and watch them

part with unwanted chemicals that they never knew what to do with," Woods said.

The partnership strongly encourages other counties without HHW collection programs to follow the example set by the Midshore Program. For more information on establishing a household hazardous waste collection initiative in your area please call (410) 758-5020.

Electronics recycling is catching on

On Saturday, May 19, representatives from the Maryland Department of the Environment (MDE), Washington County Office of Recycling, and DMC Electronics conducted an electronics recycling event at the 40 West Landfill in Washington County. DMC specializes in the recycling of electronics and is located in Hagerstown, Md.

The purpose of the event was to keep items such as TVs, VCRs, computers, monitors and other electronic equipment from

being disposed of in the landfill and to raise awareness that many electronic devices contain metal, plastic and glass that can be recycled and re-used. During the one day event approximately 3000 pounds of material were collected. Staff from DMC will separate the materials and send them to the appropriate recycler.

MDE is currently working with U.S. Environmental Protection Agency and the other states in Region III to develop an electronics recycling pilot program.

The Consent Order settles the Complaint for Preliminary and Permanent Injunctive Relief and Civil Penalties filed by MDE on April 21. Under the terms of the Consent Order, the defendants are required to implement specific corrective actions to address alleged water pollution resulting from hog farm operations at the site. The corrective actions include removal and proper disposal of dead hogs, stockpiled food material and manure from the farm; obtaining an approved nutrient management plan and animal waste management system plan; and applying for a State Discharge Permit. In addition, Everett and Deborah Thomas have been assessed a civil penalty of \$8,000. The Thomases are required to pay \$1,000 of the assessed penalty with the \$7,000 re-

mainder to be held in abeyance pending satisfactory completion of all Consent Order requirements.

Status: Case closed. (Reference # 09C0110622).

Water and Sediment Pollution Penalties, Statewide — During the period May 15 to June 15, 2001, MDE collected an additional \$3,350 in administrative penalty payments to the Clean Water Fund in settlement of alleged water pollution violations from three establishments. MDE also collected an additional \$7,213 in administrative penalty payments to the Sediment Fund in settlement of alleged erosion and sediment control violations at five construction sites.
