## 'Monster squad,' residents, earn 27th Tawes awards

A group of Eastern Shore students known as the "Monster Squad" and a local band of small town citizens shared top honors at the 27th annual Tawes Awards for a Clean Environment, presented recently in the Blue Heron Center at Quiet Waters Park in Annapolis. The Woodson Middle School in Somerset County and the Mt. Savage Historic Society and Beautification Committee won in the youth and adult categories respectively.

The Tawes Award is an environmental recognition program sponsored by the Maryland Department of the Environment (MDE) and the Maryland Petroleum Council (MPC) in the name of late Maryland Governor J. Millard Tawes, who was also the state's first secretary of the Department of Natural Resources (DNR). The award is

open to any individual, civic, community, or non-profit entity that has demonstrated outstanding efforts to enhance Maryland's environment over a period of time or with a single project.

"Government can't do it all," said MDE Acting Secretary Kendl P. Philbrick. "The people who are here today are on the front lines of cleaning up Maryland. They rolled up their sleeves and got to work and set an

## More than 1,000 rental units to be made lead safe

More than 1,000 rental apartments in suburban Maryland will undergo lead hazard reduction treatments, reducing the threat of lead paint poison. Under a settlement agreement between the Maryland Department of the Environment (MDE) and

Northwest Park Associates, a large regional property owner, 140 rental apartments in Prince George's County and 873 rental apartments in Montgomery County will undergo risk reduction treatment over the next two vears.

"These enforcement settle-

ments emphasize our message to landlords not to ignore the hazards of lead paint poisoning and the role they play in reducing that risk," said MDE Acting Secretary Kendl P. Philbrick. "MDE is continuing to focus its resources to vigorously en-

## Maryland Rock earns agency mining award

The Maryland Department of Environment (MDE) presented its annual non-coal surface mine reclamation award to Maryland Rock Industries recently. The award was presented at an Earth Day quarry open house held April 26, hosted by the Arundel Corporation, a subsidiary of Maryland Rock.

MDE presents the annual reclamation award to the company that demonstrates outstanding efforts in reclaiming surface mined land in a timely and innovative manner.

Maryland Rock won the award for its efforts at the Clark Green Acres tract located on Breton Bay in St. Mary's county. The site was a 374 acre sand and gravel operation. Extensive historical surveys were done prior to mining and several areas had to be avoided to protect historical Native American artifacts. The site is highlighted now by several deep water ponds used

by ducks, geese and fish. Bald eagles have also been spotted in the area and sometimes use the ponds as a hunting area for fish. Former wash plant settling ponds were reconfigured to create non-tidal wetlands as were some of the drainage ways. Open land areas are mowed for hay by local farmers.

In presenting the award, Ed Larrimore, MDE's Bureau of Mines Program Manager, said Maryland Rock sets a good example for mining companies across the state to follow.

Maryland Rock has won both state and national awards for other sites in St. Mary's county in the past. At the national level, the Clark Green Acres site has also received an honorable mention from the Interstate Mining Compact Commission for reclamation achievements.

Arundel Corporation hosts the open house annually at its Havre

## Fumes shown to raise youth asthma risk

Pollution from heavy traffic can make children more susceptible to asthma, wheezing and coughs, scientists said recently.

Teams of researchers from Taiwan and Germany have shown that chemicals in vehicle exhausts lead to an increased risk of respiratory disorders in children living in heavy traffic areas.

"Our results support the increasingly popular hypothesis that exposure to traffic pollution modifies children's susceptibility to allergens," said Yueliang Leon Guo of the National Cheng Kung University in Taiwan.

The Taiwanese scientists

compared air pollution levels and cases of allergic rhinitis, or hayfever, in a study that involving 800 Taiwanese schools.

They discovered that boys exposed to high levels of traffic pollution had a 16 percent higher risk of hayfever, which is linked to the development of asthma, while girls a 17 percent increase.

"While more boys than girls seem to suffer from allergic rhinitis in the general population, traffic pollution seems to have the same impact on both sexes." Guo added.

In a separate study in the European Respiratory Journal, Thomas Nicolai, of University Children's Hospital in Munich,

## Baltimore hotels join in 'green' hotel pilot

The Maryland Department of the Environment, in partnership with the environmental certification organization, Green Seal, recently completed a pilot project with five hotels in the Baltimore Harbor area. Participating hotels received a comprehensive assessment of their facility and information on the potential costs savings and environmental benefits of improved technologies, products and procedures for hotels. The five participating properties were the Admiral Fell Inn, Holiday Inn Inner Harbor, Renaissance Harborplace Hotel, Sheraton Inner Harbor, Tremont Plaza Suites Hotel.

The assessments at the Baltimore hotels addressed the economic costs and potential environmental impacts of the properties' major mechanical systems (HVAC, lighting, water) and procurement policies for equipment, paper products, and cleaning supplies based on Green Seal's Environmental Standard for Lodging Properties (http://www.greenseal.org/standards/lodgingproperties.htm). To date, two properties, the Admiral Fell Inn and the Tremont Plaza Suites Hotel, have expressed interest in obtaining Green Seal certification.

In addition to helping reduce operating costs, certification as a green hotel can increase revenue from environmentally conscious travelers and those from institutions with a green travel or meeting policy. As MDE Acting Secretary Kendl Philbrick noted, "This project

has offered an opportunity to recognize the successful measures already in place at these five hotels. We hope it will also provide motivation to other lodging properties throughout Maryland to consider "green" initiatives that benefit both their bottom-line and the environment."

## New database collects stormwater projects, other info

A new database from the Maryland Department of the Environment (MDE) will provide civil engineering professionals and those interested in stormwater management access to a catalog of completed projects. The statewide Maryland urban stormwater implementation data report is expected to become publicly available this month on MDE's website, www.mde.state.md.us.

The compilation of the Maryland stormwater database stems from a requirement in Code of Maryland Regulation that requires each county or municipality to submit to MDE a form advising completion of each stormwater management practice within 45 days of the project's final installation. The notice of construction comple-

tion forms are known to practitioners as a "NOCC."

In 1990, stormwater implementation in jurisdictions with populations of at least 100,000 became subject to the federally mandated National Pollutant Discharge Elimination System (NPDES) stormwater program. Under this program, the department must issue separate municipal storm sewer system permits that require localities to control pollutant discharges from medium to large storm drain systems. Because the NPDES municipal stormwater programs generate large data reports, the affected jurisdictions have opted to replace the aforementioned NOCC reports with annual computerized data tables.

MDE has integrated all data from submitted NOCC reports and annual computerized data tables into one file – the stormwater projects implementation database, which currently contains approximately 23,000 records for the period from 1985 to 2002.

The database contains attributes of structural devices and management practices designed to temporarily store or treat stormwater runoff for the purpose of mitigating flooding and reducing land-to-stream pollution (particularly sediment, phosphorus, and nitrogen).

"Until now, the primary user of this data has been the Maryland Department of Natural Resources' modeling group, who reconfigure them as input data for the Chesapeake Bay Program Watershed-Water Quality model," said Richard Eskin, deputy director of MDE's Technical & Regulatory Services

Administration. "In the last year, two prospective users have expressed interest in incorporating the stormwater data in their studies."

For instance, in recent months MDE staff used the database to develop Total Maximum Daily Loads (TMDL) to estimate the maximum amount of a pollutant that could discharge into a water body without violating mandated water quality standards. And the West Nile Interagency Group has utilized the information in the preliminary phase of a surveillance study that includes the identification of possible mosquito breeding sites in Maryland.

The database includes four relevant items: stormwater project sites; project completion dates; land acres served by a

## 'Water—Use it Wisely' campaign gets underway

The Metropolitan Washington Council of Governments (COG), in partnership with area water utilities, the Maryland Department of the Environment, the Virginia Department of Environmental Quality, and the United States Environmental Protection Agency launched the first regional campaign to promote year round wise water use on May 20.

Using materials developed through the national "Water, Use It Wisely®" the campaign encourages residents and businesses across the region to use water wisely by demonstrating simple wise water use practices in and around homes and businesses. Campaign media include broadcast, theater, and transit advertising and public service announcements, as well as public school education and community outreach efforts.

At the launch, elementary and middle school students from the District of Columbia and Alexandria, Va. joined Wise Water Use partners (currently 34 organizations including area water utilities, commissions, and authorities; COG, local governments; the State of Maryland; Commonwealth of Virginia; and the U.S. Environmental Protection Agency) at a model home in Prince George's County to demonstrate various water saving practices. Examples of the water savings tips exhibited today and promoted in the campaign include:

- Turn off the water while you brush your teeth and save up to 4 gallons per minute.
- Use a broom instead of a hose to clean your driveway and sidewalk and save up to 80 gallons of water every time.
- Use a hose nozzle and turn off the water when you wash your car and save more than 100 gallons

Supervisor Penelope Gross and Chair of COG's Water Supply Task Force stated, "The campaign was designed to be See WISE, Page 7

## Hybrid cars added to MDE's vehicle fleet

The Maryland Department of the Environment (MDE) recently updated its vehicle fleet with two gasoline-electric hybrid passenger cars. The purchase of the 2003 Honda Civic hybrids are in keeping with MDE's mission of pollution prevention and protecting air quality because gasoline-electric hybrids are fuel efficient, low emission vehicles. Major sources of air pollution include mobile sources, e.g. cars and trucks, and the fuels used to power them. Cars that are fuelefficient produce fewer emissions.

The Civic hybrid is an ultra-low

emissions vehicle that gets an estimated 47 miles per gallon from a combination electric motor and gasoline engine. The battery pack, which powers the electric motor, is self-sufficient and recharges itself automatically when decelerating through regenerative braking, as well as when cruising. In other words, the battery never needs to be plugged in for recharging.

Government agencies are required under the federal Energy Policy Act to make 75 percent of new fleet purchases be alternative fuel vehicles. In part, this requirement is intended to reduce reliance on

foreign oil.


"Although gasoline-electric hybrids are not covered under the Energy Policy Act because they use gasoline, these vehicles are consistent with MDE's philosophy of promoting advanced vehicle technology that reduces emissions and fuel consumption," said Tim Shepherd of MDE's Mobile Sources Control Program.

stormwater project; stormwater project types. The latter data item, stormwater project types, consists mostly of artificial wetlands (shallow marshes), dry ponds, infiltration basins, infiltration trenches, porous pavements, sand filters, oil/ grit separators, roadside swales, and underground storage facilities. The definitions and specific functions of these structures and practices - collectively called "urban stormwater best management practices" (BMPs) - will also be posted on the website.

## Meeting looks at 'greening' hospitality industry

Germany, and his team compared traffic density and exposure to pollutants and health records of nearly 4,000 children.

Youngsters living within 50 yards of roads where more than 33,000 vehicles passed by each day were almost twice as likely to suffer from asthma than other children.

"High vehicle traffic was associated with asthma, cough and wheeze, and in children additionally exposed to environmental tobacco smoke, with allergic sensation," Nicolai said in the report.

#### Certain fish species on verge of collapse

Industrial fishing fleets have systematically stripped 90 percent of the giant tuna, swordfish, marlin and other big fish from the world's oceans, according to a new study that suggests the virtual collapse of these stocks.

Fishing fleets are competing for the remnants of the biggest fish in the oceans, concludes a 10-year research project reported recently in an issue of the science journal Nature.

"Fishermen used to go out and catch these phenomenally big fish," said Ransom A. Myers, fisheries biologist at Dalhousie University in Halifax, Nova Scotia. "But they cannot find them anymore. There're not there. We ate them."

Myers' study, with Dalhousie University colleague Boris Worm, is the third in a series of recent scientific papers challenging the notion that the oceans are so resilient they can provide an inexhaustible supply of fish to feed the world.

The first study, by Jeremy Jackson of the Scripps Institu-

tion of Oceanography in San Diego, looked at the decline of many ocean species over several centuries and documented how it set in motion the collapse of kelp forests and coral reefs.

The second study, by Daniel Pauly of the University of British Columbia, focused on how the worldwide catch of all seafood has been on the decline since the late 1980s, as evidenced by the ever-dwindling catches of an expanding global fishing fleet.

Myers' study focused on the demise of what was once considered "the blue frontier," caused by the introduction of industrial fishing in the years immediately after World War II. It was then that most of the biggest fish were pulled from the sea, never to rebound because of continuing fishing pressure. The

loss of these fish presents a considerable problem for fishery managers from the 192 nations that signed a declaration last year at a United Nations summit to restore fish to healthy levels by 2015.

Pauly said the new study shows that in most places, fisheries managers are arriving too late. He likens the situation to saving a forest after harvesting has taken place. Yet tuna industry scientists immediately challenged the study's conclusions, saying they were simplistic and inconsistent with other data.

In the study, Myers and Worm analyzed 47 years of detailed fishing records kept by the Japanese long-lining fleet, in which ships unfurl baited hooks from lines that stretch up to 50 miles.

removing debris and preventing erosion."

Over 90, sixth grade students, known as the Monster Squad Team, at Woodson Middle School, worked together for a school beautification and public education project. The Monster Squad Team, led by Jessica Simone, Lisa Dize, Jean Adams and John Robertson, established a partnership with the Chesapeake Bay Trust, the City of Crisfield's Police Department and Public Works to clean debris from a quarter mile of tidal ditches surrounding their school, planted native trees along a tidal ditch's edging to prevent erosion and participated in an environmental education program aboard The Lady Maryland. As part of a public awareness campaign, the Monster Squad's posters were displayed in several Crisfield businesses.

The Mt. Savage Historic Society and Beautification Committee of Allegany County won in the adult category. They earned the award for their efforts in taking the initiative to solve an environmental problem and turn the project into a sustained

community-wide effort to beautify and preserve their immediate environment.

In 1995, as a result of complaints of trash and debris in the scenic Jenning's Run trout stream area, the committee organized a one-day cleanup event involving students. Since the initial cleanup, Mt. Savage has organized and conducted annual stream and roadside cleanup events without municipal employee resources. The small, unincorporated community regularly brings together volunteers, organizations, students and businesses in cleanup, beautification and fundraising efforts. They have also expanded their cleanup efforts to include household trash pickup to minimize illegal dumping.

The Runner-up in the youth category was the Whittier Elementary School in Frederick County, led by first grade teacher Deborah Thackston. The school's 600 students motivated the community, involved neighboring schools and challenged business to pledge financial support to their recycling efforts that netted nearly 2,000 pounds of alu-

minum. Students donated the money generated by the recycling project to the Frederick County Earth & Space Science Lab Expansion Project. Their achievement was based on working together to help others and learning to be good citizens and stewards of the environment.

The Runner-up in the adult category was Doug Hutzell of Washington County, who is employed by MDE.

Hutzell was recognized for his years of preserving and protecting Maryland's waterways and the environment on his own time. In 1995, as the Conservation Representative for the Antietam Fly Anglers, Hutzell organized a

clean up of Beaver Creek, a tributary of Antietam Creek in Washington County. Since the initial clean up, he has organized additional cleanups which reduced stream erosion, removed trash and log-jams from Beaver Creek. His most significant project is the rehabilitation of the Barr Meadow portion of Beaver Creek. Hutzell's efforts on the Barr Meadow project are a model for other stream conservation groups.

used year round regardless of drought conditions. By providing and practicing simple ways to save water, citizens of the region can help support efforts to efficiently manage regional water resources and supplies."

Following the Drought of 1999, area officials questioned the region's ability to effectively communicate and coordinate its drought response, and its ability to meet the growing demands upon regional water supplies. To address those concerns, COG's Board of Directors established a Water Supply Task Force. The regional Wise Wa-

ter Use Campaign grew out of the coordinated regional drought response and awareness plan developed by the Task Force.

The "Water, Use It Wisely®" campaign was created originally for communities in Arizona. Research in that area indicated that consumers already knew why they should conserve water, but needed to know a variety of ways in which to do it. Beginning with one Arizona jurisdiction and a small pool of money, the campaign spread quickly to other cities. In two years, it ballooned to a full-scale advertising and community re-

lations success, with ultimate investments of more than one-third of a million dollars. In addition to the metropolitan Washington region, the campaign has been adopted in such areas as Seattle, Washington, North Carolina, and the Hampton Roads, Virginia.

Market research conducted in the Washington region supported use of the "Water, Use It Wisely®" materials. Each jurisdiction/utility can participate to the level that suits it individually, while demonstrating a regionally united and coordinated effort. Because water supply and reasons for saving water can vary greatly depending on location, even for neighboring utilities, campaign materials focus on everyday tips that can help residents and businesses change their behaviors and attitudes about using water wastefully.

Campaign materials will continue to be developed and distributed in the coming years, with new ads in additional languages that can reach different target populations. Sometime next fall, the campaign will expand to education-based efforts in area elementary and middle schools.

force the state's lead laws. At the same time, MDE values the role responsive property owners play in reaching compliance."

The comprehensive settlement agreement resolves a notice of violation that MDE issued against Northwest Park Associates as a result of the presence of a lead poisoned child in one of its Prince George's County units, located in the 100 block of Southampton Drive. The child resided in a unit where lead hazards were present and recorded a blood lead level of 30 micrograms per deciliter. Blood lead levels greater than 10 micrograms per deciliter are considered to be an elevated level by the Centers for Disease Control. MDE was notified of the impact to the child as a result of blood lead testing from another source.

State lead laws require that all rental properties built before 1950 be registered with MDE and comply with certain risk reduction treatments. The treatments are required whenever there is tenant turnover, upon receipt of notice that a property has chipping, peeling, flaking paint or that a child with an elevated blood lead level resides in the dwelling unit. Property owners also have to insure that

de Grace quarry. The event typically draws between 2,000 and 3,000 visitors. In addition to the open house, Arundel is active in the local school system and has constructed a wetlands park that is open to the school systems in Harford County for outdoor education.

Arundel Corporation was also honored at that time for community outreach and good neighbor policies for its Havre de Grace quarry operations. 50 percent of their rental units have been brought into compliance with the risk reduction standards regardless of whether there was turnover or other triggering event.

As part of the settlement agreement, Northwest Park agreed to voluntarily bring the 873 rental apartments in Montgomery County, which were built after 1949, into compliance with the lead free standard in exchange for a reduction in its civil penalty that could have reached \$100,000.

This settlement is another example of MDE's enforcement strategy to encourage landlords to exceed minimum state lead hazard reduction standards to make properties safer for families. 

#### Air & Radiation Management Administration

Unilever Home and Personal Care, U.S.A. - Baltimore City--On April 15, MDE issued a Notice of Assessed Penalty to Unilever in the amount of \$25,000. Unilever operates a soap and liquid detergent manufacturing plant in east Baltimore. An inspection conducted by MDE found that Unilever violated its permit by failing to perform any of the required visible emissions observations for a period of 14 months. Status: Unilever has 30 days to request a hearing on the Assessed Penalty. (Reference #AQCP 02-14A)

University of Maryland Medical Systems (UMMS) Radiation Oncology - Baltimore City--On April 21, MDE issued a Complaint and Administrative Penalty of \$1,000 against UMMS Radiation Oncology for a misadministration that occurred in 2002. UMMS Radiation Oncology treated the wrong patient with a doctor's prescription of radiation. Root cause and corrective actions have been completed. Status: UMMS has 30 days to request a hearing on the Administrative Penalty. (Reference #RHP 02-20)

Charles Pasqualini, D.D.S. – Cecil County--On May 1, MDE issued a Complaint, Order, and

Administrative Penalty of \$1,000 against Dr. Pasqualini for failure to renew the registration of the radiation machines at his dental facility. **Status:** Dr. Pasqualini has 10 days to appeal the Order and 30 days to request a hearing on the Administrative Penalty. (Reference #RHP 02-18)

William Strahan, D.D.S. – Montgomery County--On May 1<sup>st</sup>, MDE issued a Complaint, Order, and Administrative Penalty of \$11,000 against Dr. Strahan for failure to resolve violations cited during a routine dental facility inspection. Status: Dr. Strahan has 10 days to appeal the Order and 30 days to request a hearing on the Administrative Penalty. (Reference #RHP 02-19)

J. C. Darling Plumbing & Heating - Caroline County--On May 2, MDE issued a Notice of Assessed Civil Penalty in the amount of \$2,000 to Darling Plumbing. Darling violated air quality regulations by conducting open burning without obtaining a permit, burning waste wood materials from an off-site location and by creating dense smoke that caused a nuisance for nearby residents. Status: Darling has 30 days to request a hearing on the Assessed Penalty. (Reference #AQCP 02-48A)

B&J Auto Salvage and Elwood's Auto Exchange – Washington County--On May 6, MDE issued a Notice of Proposed Civil Penalty in the amount of \$10,000 to B&J Auto Salvage and Elwood's Auto Exchange. These two auto salvage yards, co-owned by the same individuals, are charged with violating open burning regulations at the two sites. The violations include burning without a permit, creating a nuisance and air pollution, burning materials that produce dense smoke, and burning off-site materials. Status: B&J/ Elwood's has 10 days to request a meeting on the Proposed Penalty. (Reference #AOCP 02-42A)

Mirant Mid-Atlantic - Prince George's County--On May 8, MDE finalized a Consent Order with Mirant to settle air pollution violations at its Chalk Point electrical generating station. The violations were determined by a particulate stack test which showed an exceedance of applicable particulate emissions limits. Mirant determined that the cause of the violations was malfunctioning air damper linkages. Mirant made the repairs and a retest demonstrated compliance. The settlement includes a \$20,000 penalty. Status: Case Closed. (Reference #AQCP 011-200300001)

Homestead Mobile Estates – Cecil County--On May 9, MDE issued an Assessed Civil Penalty in the amount of \$4,500 to Homestead Mobile Estates for open burning violations. Homestead operates a mobile home park near Port Deposit. The facility violated air quality regulations on

County has agreed to complete secondary clarifier improvements and undertake best operational efforts to meet total nitrogen loading goals identified in the facility's NPDES permit by February 28, 2007. The agreement also establishes interim performance standards and stipulated penalties exceedances of those standards and other established permit effluent limits and compliance agreement milestones during periods of construction and actual start-up of clarifier improvements.
