Pre-Mix Industries - Prince Georges County

On September 19, 1997, Pre-Mix Industries paid an assessed administrative penalty of \$12,000 for violations of Maryland's air pollution requirements at their sand and aggregate production facility. The violations consisted of excessive visible emissions and creating a nuisance dust situation on neighboring properties. Under a Corrective Order previously issued by MDE, the Company has achieved compliance.

Status: Case Closed

Consolidated Pharmaceutical Group, Inc. (CPG) - Anne Arundel County

On October 1, 1997, MDE assessed an administrative penalty of \$9,500 against CPG for violating air pollution requirements at their pharmaceutical manufacturing plant in northern Anne Arundel County. The violations consisted of creating a nuisance odor off of their property and violating a permit condition. The Company has since returned to compliance.

Status: The Company has 30 days to pay the penalty or request a hearing. (Reference # ACP 97 - 07A)

Paramount Feed & Supply, Inc. - Washington County

On October 2, 1997, MDE assessed an administrative penalty of \$7,000 against Paramount Feed & Supply for violating air pollution requirements at their agricultural feed mill in Washington County. This facility processes various grains into livestock feed products. Dust and other particulate matter from their process created dust and nuisance conditions in the surrounding community leading to numerous complaints from citizens. Under a Corrective Order previously issued by MDE, the Company is achieving compliance. Status: The Company has 30 days to pay the penalty or request a hearing. (Reference # ACP 97 - 05A)

On October 2, 1997, MDE assessed an administrative penalty of \$5,500 against Maugansville Feed Service for violating air pollution requirements at their agricultural feed mill in Washington County. This

facility processes various grains into livestock feed products. Dust and other particulate matter from their process created dust and nuisance conditions in the surrounding community leading to numerous complaints from citizens. Under a Corrective Order previously issued by MDE, the Company is working to achieve compliance. **Status:** The Company has 30 days to pay the penalty or request a hearing. (Reference # ACP 97 - 06A)

Chelsea Environmental Corporation - Vienna, Virginia

MDE issued a Show Cause Order on September 11, 1997 to Chelsea Environmental for failing to appear at a September 3 prehearing conference at the Office of Administrative Hearings concerning their appeal of a \$10,000 assessed penalty and a license denial action resulting from numerous violations at an administrative building (#1633) at Andrews Air Force Base, Camp Springs MD. Status: The company had until September 21, 1997 to comply with the Show Cause Order. As of the date of this report, the company has failed to comply. (Reference # ACP 96-06A)

Sheets -- Dentist, Allegeny County

On September 8,1997, MDE assessed a \$3,000 administrative penalty against Dr. Sheets for deficiencies related to dental x-ray machine operator safety and x-ray film development peractices.

Status: Dr. Sheets has appealed the penalty assessment. (Reference # 23-0020)

Kurdziolek -- Dentist, Montgomery County

On September 12, 1997, MDE assessed a \$2,000 administrative penalty against Dr. Kurdziolek for deficiencies related to dental x-ray machine operator safety and x-ray film development practices.

Status: The penalty has been paid. (Reference #31-1443)

A fire broke out in the wood waste piles and continued to burn for several days. The firefighting efforts were hindered by the lack of access to some of the pile areas, caused by the violations. Both air and water pollution occurred from this fire

Status: Pending. Violations have been corrected. (Reference #C-O-AP-97-NWW-002)

E2CR, Inc. – Baltimore County

On September 11, a Complaint and Order for \$15,000 was issued for the improper removal of two underground storage tanks and the subsequent oil discharge on to the ground at the Maryland Air National Guard facility in Essex in June, 1997. The company was ordered to perform a site assessment and submit a corrective action plan for clean up. Additionally, penalties for \$2,000 were issued to each of the two UST certified removers who performed the improper removal.

Status: Settled. The property has been cleaned up. (Reference #COV-97-062)

Redland Genstar, Inc. - Baltimore County

On September 18, 1997, MDE issued a unilateral administrative penalty action against Redland Genstar for NPDES permit violations; specifically, for the failure to submit biomonitoring test results and for unauthorized toxic discharges from its calcium carbonate plant in Cockeysville. The action seeks a \$50,000 penalty.

Status: Genstar has eliminated the discharges from the plant. MDE met with the company on October 14, 1997. Tentative terms for settlement have been reached pending negotiation of final consent order.(Reference #AP-98-0004).

Domino Sugar Corporation - Baltimore

On October 1, 1997, in a coordinated effort with the U.S. Environmental Protection Agency (EPA), MDE issued two separate administrative enforcement actions against Domino Sugar Corporation for Clean Water Act violations at the company's sugar cane refinery located in Baltimore's Northwest Harbor. MDE assessed a \$9,000 administra-

tive penalty for pH and temperature effluent violations of the facility's discharge permit and also issued an administrative order requiring submission of a corrective action plan to address effluent violations and prevent the discharge of raw sugar into the Patapsco River. EPA has assessed a separate penalty of \$50,000 for failure to comply with provisions of the discharge permit which are designed to prevent the discharge of raw sugar into the river.

Status: Domino Sugar has appealed MDE's order and \$9,000 penalty assessment. The company has 20 days to request a hearing from EPA on the assessment of the \$50,000 penalty. (Reference #AO-98-0016, #AO-98-0019)

Spurry Family Partnership (Bay Hundred Seafood) - Talbot County

On October 6, 1997, MDE issued an administrative consent order to Spurry Family Partnership which resolved the Order portion of the administrative Complaint, Order and Penalty #AO-97-0006 issued to the company on October 2, 1996 for violations of Maryland water pollution control law. The consent order requires the facility to implement corrective actions for wastewater treatment at the facility's seafood processing operation and restaurant located on Wade's Point Road in McDaniel.

Status: The administrative penalty is currently under appeal. (Reference #96-MDE-WMA-069-566).

Tread Shred, Inc. - Prince George's County

On October 14, 1997, MDE issued an Administrative Complaint, Order and Penalty against Tread-Shred, Inc., a scrap tire recycling facility, and We-Rek, Inc., an associated auto salvage operation, and owner/ operator William Egri. The action is for violations of the scrap tire recycling permit issued to Tread-Shred and for violations of the general storm water discharge permit issued to We-Rek that occurred at 17305 Manning Drive in Accokeek. The action seeks a suspension of Tread-Shred's scrap tire permit and a corrective action plan requiring implementation of a storm water pollution prevention plan to eliminate contaminated runoff from the site. A \$50,000 penalty has been assessed against Tread-Shred for violations of the scrap tire permit and a separate \$50,000 penalty has been assessed against We-Rek for water pollution violations.

Status: The parties have 10 days to appeal the administrative orders and 30 days to appeal the penalty assessment. (Reference #WAS-97-RDE-005 and #WMA-AO-97-0021)
