MDE'S NOSE COPS ON THE BEAT

The nose knows.

At least that's what the Maryland Department of the Environment (MDE) Air and Radiation Administration (ARMA) inspectors hope. As MDE's "stink" police, ARMA's air quality inspectors must rely on their noses to get through smelly situations. ARMA receives about 1,000 complaints each year concerning foul smells in the air. In response to these complaints, ARMA inspectors investigate the smells, and try to determine the cause of the odors in order to solve the problem.

Odors in the air can be difficult to track down. Many times the odor is intermittent in nature, making it difficult for an inspector to detect an odor. Odor complaints can vary from the very vague to the very specific. Some complaints come in as merely "the air doesn't smell right today can you do something about it?" Others are much more specific wherein the complainant is relatively certain of the source of the offending odor. Sources of odor vary from factories, to farming, to auto paint shops, to composting operations, to wastewater treatment plants. Some of the odor situations that ARMA gets involved in often end up being neighbor disputes.

ARMA responds to odors 24 hours a day, seven days a week. During normal working hours, complaints are received and responded to by office staff. After hours, ARMA has a duty officer

program that allows for response to air quality complaints. This after-hours response capability has been a very useful aspect of our program because odors are an around-the-clock issue.

After a complaint is received by ARMA an inspector is dispatched to the location to assess the situation. If in the judgement of the inspector a nuisance odor is present, a Notice of Violation (NOV) is issued to the source of the odor if that can be determined. MDE then follows-up with the source to ensure the odor is eliminated. This follow-up often includes conversations and meetings with the odor source to review options for eliminating the odors.

Many of our odor situations are addressed informally, even without the issuance of an NOV, with ARMA playing the role of mediator. This works well in many cases by optimizing the use of resources while hopefully solving the situation amicably. If an odor problem cannot be resolved informally, ARMA has formal enforcement tools at its disposal to seek compliance. These actions would include penalties, corrective orders, or injunctive relief.

While people may have difficulty grasping the vagueness of trading air pollution emission credits, or figuring out if ozone is good or bad, or are uncertain if putting their vehicle on a treadmill will improve air quality, they know full well

when a nasty smell is stinking them out of their backyard. Some of the most upset people that ARMA has to deal with are those that attempted to have a backyard cookout over the weekend and had to move the party inside on a beautiful day because of a foul odor wafting across their property.

The source of an odor is not always easy to determine. For example, there is the infamous "cat urine" odor that has been intermittently smelled in the area of the Francis Scott Key Bridge for years. We would get very occasional and intermittent complaints (one or two per year) of this odor from different complainants. But it was often from someone driving on the highway, and was never traced to a specific source, even though our inspectors are routinely in this industrialized area.

It is often the case that a very mild odor can cause great consternation to a citizen or group of citizens. We have encountered situations where our inspector can barely detect an odor, and may be of a degree that other neighborhoods have tolerated. But this is where the psychological impact comes in. It's a little like Chinese water torture. Once you've been exposed to the odor, and it has started to bother you, even the faintest trace of it can cause a highly emotional response. In the nose of the inspector, the same odor may not be detectable or strong

enough to constitute a "nuisance" from an enforcement perspective.

Odor situations can sometimes be difficult to resolve. One of the difficult situations we encounter is an existing operation (factory, farm, etc.) that previously had a lot of land around it or a few neighbors that were not bothered by the odors. With the rapid development currently occurring in the state, often in previously rural areas, a clash often occurs between the existing farming community and residents of new housing built on an adjoining farm that has been sold. The new residents find their tranquil new life rudely disturbed by what are actually normal odors for the farming community. It is often a clash of two cultures, with ARMA caught in the middle.

We do the best we can to mediate the situation, but often in these types of cases it just comes down to enforcing the law and letting events take their course. It is also usually the case that the new residents had no idea of such potential problems when purchasing their new homes.

Stratus Petroleum - Baltimore

The Complaint Order and Civil Penalty listed in the June, 1997 MDE Environment has resulted in a \$3,000 penalty for not reporting a spill from an aboveground storage tank in a timely manner.

Clean Rock Industries, Inc. - Washington County

The Complaint Order and Civil Penalty listed in the January, 1998 issue of the MDE Environment has resulted in a \$3,000 penalty for receiving oil-contaminated sludge containing waste cutting oil and other products, for performing a non-permitted solidification process and for storing the sludge in a non-permitted area.

The previous violations included failure to monitor workers' exposure to radiation, use of deficient x-ray film development solution, and unsatisfactory patient viewing arrangements when operating the x-ray machine. The order required the Group to cease using the x-ray machine within 20 days of receipt of the order.

Status: Pending (Reference #RHP 98-10)

Johns Hopkins Bayview Medical Center - Baltimore City

On August 11, 1998, MDE issued a complaint and assessed an administrative penalty against Hopkins Bayview in the amount of \$10,500 for deficiencies in operation of the Nuclear Medicine Department related to, among other things, radiation exposure surveys, the testing of a radiation dose calibrator, and the securing of radioactive materials.

Status: Pending (Reference #RHP 98-14)

Allsafe Lead Services, LLC - Odenton - Anne Arundel County

On July 27, 1998, MDE issued a Complaint and assessed an administrative penalty in the amount of \$3,250 against Allsafe Lead Services for failure to adhere to the conditions

of a license issued to the company by MDE for the use of lead paint analyzers. The analyzers contain a radioactive material. Inadequate storage and testing of the analyzers, deficiencies in signage and in radiation dosage badge monitoring were the license conditions which the licensee failed to meet.

Status: Pending (Reference #RHP98-12)

Mitchell Plumbing and Heating Co., Inc. - Baltimore City

On August 5, 1998, MDE assessed an administrative penalty against Mitchell Plumbing in the amount of \$5,000 for removing asbestos from a residence in Baltimore City without securing the necessary license from MDE, for failing to take reasonable measures to prevent asbestos fibers from becoming airborne and for failing to notify MDE of the removal.

Status: Pending (Reference #98-07A)

July 14 - August 14, 1998

Mathew Eby Farm - Washington County

On July 23, 1998 a Consent Order between Mathew Eby and MDE was issued. The Consent Order requires Mr. Eby to file a Notice of Intent to be covered under MDE's General Discharge Permit for Concentrated Animal Feeding Operations. The Eby Farm must also implement a plan approved by the Washington County Soil Conservation District for the effective handling of animal waste to prevent future unlawful discharges of wastewater to waters of the State and implement a storm water diversion plan. Mr. Eby has agreed to pay a \$6,500 penalty for the unlawful discharge of manure into Resh Run, which resulted in a fish kill situation. The first payment of \$2,000 has been received.

Status: Settled (Reference #CO-99-0004)

Theodore Passyn - Talbot County

On June 12, 1998, MDE signed a judicial consent order with Theodore Passyn/T.B. Passyn & Sons, Inc. which settled the September 22, 1995 Complaint, Order and Penalty and the March 31, 1997 Amended Complaint, Order and Penalty against Passyn & Sons for violations of sediment and erosion control laws and wetlands laws. Passyn & Sons will pay a penalty of \$10,000. According to the agreement, Passyn & Sons will bring all phases of the Matthewstown Run Subdivision into compliance with sediment and erosion control laws.

Status: Settled (Reference OAH NO. 95-MDE-WMA-002-571)

Shank Farms, Inc. - Washington Co.

On July 6, 1998 MDE filed a civil action against Garry Shank of Shank Farms, Inc. in the Circuit Court for Washington County for a manure overflow from the farms' waste lagoon into Marsh Run, which resulted in a significant fish kill.

The civil action requests injunctive relief requiring Mr. Shank to obtain a General Discharge Permit for a Concentrated Animal Feeding Operation, implement an animal waste management plan approved by the Washington County Soil Conservation District and install storm water diversions on the farm. On July 17, 1998, MDE met with Garry Shank to discuss the terms of the civil action.

Status: Case Pending (Reference #JO-99-0023)

Darling International, Inc. - Dorchester County

On August 13, 1998 MDE and Darling International finalized a Complaint and Consent Order addressing effluent violations and Darling's NPDES permit. Under the Order, Darling International is required to implement and complete improvements to the wastewater treatment facility in order to achieve compliance with their state and NPDES discharge permit. Darling International will also pay a \$1,000 penalty, due in full by August 31, 1998.

Status: Case Pending (Reference #CO-99-0013)

Shaffer Construction, Inc. - Allegany County

On July 16, 1998 an Administrative Complaint and Penalty was issued to Ron Shaffer and Shaffer Construction, Inc. for sediment pollution violations, requiring the payment of a \$2,970 penalty.

Status: Case Pending (Reference #CO-98-0073)

City of Havre de Grace - Cecil Co.

On June 24, 1998, MDE signed an administrative consent order requiring that the City of Havre de Grace operate and maintain the wastewater treatment to ensure compliance with the State discharge permit effluent limitations. The City of Havre de Grace has installed additional automatic control equipment to ensure compliance with the total residual chlorine effluent limitation. The City of Havre de Grace has agreed to pay an up front penalty of \$2,500 and has agreed to expend a minimum of \$10,000 to accomplish a Supplemental Environmental Project (SEP) as approved by MDE. The SEP shall be completed by July 15, 1999.

Status: Settled (Reference #CO-99-0010).

Allen Family Foods - Talbot County

On August 13, 1998, MDE filed a judicial complaint for injunctive relief and civil penalty against Allen Family Foods, Inc. in the Circuit Court of Talbot County for violations of the State water pollution control laws. The complaint alleges that the application of wastewater by Allen Family Foods violated its State discharge permit and contaminated the groundwater by increasing the levels of nitrates above the drinking water standards. The action requests that the court assess civil penalties of up to \$10,000 per day for each day of violation, require Allen Family Foods to comply with the terms of the State discharge permit, perform a study to determine the extent of groundwater contamination and submit a plan to remediate the contamination.

Status: Case Pending (Reference Case Number: 20-C-98-003515).

Tyson Foods, Inc. - Worcester Co.

On July 23, 1998, MDE filed a judicial complaint for injunctive relief and civil penalty against Tyson Foods, Inc. in the Circuit Court of Worcester County for violations of State water pollution control laws. The judicial action alleges that Tyson Foods violated the Removed Substance Management Plan and placed pollutants in a position likely to pollute waters of the State. The action requests that the court assess civil penalties of up to \$10,000 per day for each day of violation, require Tyson Foods to cease the application of industrial sludge at the site in question and implement a plan approved by the Department for future industrial sludge disposal.

Garden State Tanning, Inc. - Washington County

On August 7, 1998 in a coordinated enforcement action with the U.S. Environmental Protection Agency, MDE issued an administrative complaint, order and penalty against Garden State Tanning for violations of the fecal coliform, total ammonia, total residual chlorine effluent limitations, as well as laboratory analytical requirements of the facility's State discharge permit. The Order requires a corrective action plan to ensure compliance with discharge permit requirements. A penalty of \$50,000 has been assessed.

Status: Case Pending (Reference #AO-99-0005).

Cumberland Cement and Supply, Inc. - Allegany County

On July 15, 1998, MDE issued an administrative complaint, order and penalty against The Cumberland Supply and Cement Company for violations of the monitoring and reporting requirements of the State discharge permit and violations of the total suspended solids effluent limitations of the permit. The Order requires a corrective action plan to ensure compliance with discharge permit requirements. A penalty of \$50,000 has been assessed. Cumberland has requested a hearing in this case.

Status: Case Pending (Reference #AO-99-0003).

Town of Willards - Wicomico Co.

On July 21, 1998, MDE and the Town of Willards signed an administrative consent order requiring the implementation of corrective measures to address violations of the BOD and TSS effluent limitations of the facility's State discharge permit. MDE has agreed to complete evaluation of the permit and to conduct a water quality study of Burnt Mill Branch by December 31, 1998. Willards is required to complete all plant improvements no later than December 31, 2001 or three years from the date the facility receives the results of the Department's evaluation. The Town of Willards has agreed to pay an up front penalty of \$1,000.00 and has agreed to spend a minimum of \$10,000 to complete a Supplemental Environmental Project no later than July 21, 2000.
