Dear Mr. Dodson:

The Oil Control Program recently completed a review of the case file for the above-referenced property, including the *Quarterly Monitoring Report - December 2, 2014*. Your consultant requested discontinuance of annual sampling of the potable wells located at 900, 902, and 908 Rosemont Drive and 840 Jefferson Pike. Sampling has been conducted at these addresses from 2005 to 2014. All sampling results collected during this monitoring period have been non-detect for petroleum concentrations.


Based on our review, the Department hereby approves sampling reductions, contingent upon the following modifications:

- 1) The Department approves the request to eliminate annual well sampling at the following residences: 900, 902, and 908 Rosemont Drive and 840 Jefferson Pike.
- 2) Continue annual off-site potable well sampling at: 847-A Jefferson Pike; 854 Jefferson Pike; and 3833, 3823, and 3839 Burkittsville Road.
- 3) Continue sampling all monitoring wells and tank field monitoring pipes as outlined in the Department's correspondence dated July 8, 2014. Samples collected must be analyzed for full-suite volatile organic compounds (VOCs), including fuel oxygenates and naphthalene, using EPA Method 8260. In a previous correspondence, the Oil Control Program suspended required sampling of total petroleum hydrocarbons - diesel and gasoline organics (TPH-DRO and GRO) using EPA Method 8015B, but reserved the right to re-activate this requirement in the future.
