Call to Order

Board Chairman Hairston called the meeting to order in the Aeris Conference Room at 9:02 am.

Review and Adoption of Proposed Meeting Agenda

Chairman Hairston presented the agenda for review and approval and asked for any corrections. Item 2a was added to allow meeting guests to introduce themselves to the Board. A motion to approve the proposed meeting agenda with changes was made by Mr. Hartman and seconded by Ms. Quinn. Motion carried.

Review of Draft Meeting Minutes

Chairman Hairston presented the draft minutes of the February 22, 2017 meeting for approval and asked for any corrections. A motion to approve the draft meeting minutes was made by Ms. Quinn and seconded by Mr. Shannahan. Motion carried.

Industry Correspondence/State of the Industry

Meeting guests, Dave Kelly and Mike Isom with the Maryland-Delaware Water Well Association, addressed the Board regarding members' complaints of inconsistent interpretation of Maryland Well Construction regulations, specifically the handling of well permit issuance in various counties. Some counties charge higher fees than others, for example Anne Arundel. Also there are indications that some counties have required licensed electricians to run the electrical line between the well and the house or building.

The Board cannot prevent counties from charging fees and does not advocate licensees not adhering to County policy. However, counties cannot prevent licensees from doing work authorized by their licenses. Ms. Nolen will draft letters to Cecil and Frederick counties asking if they require licensed electricians to run electric from the well to house.

The other issue discussed is the process that requires currently licensed Well Rig Operators to pass the Apprentice exam a second time in order to sit for the Journeyman exam. The Board will discuss this issue in context with the process for out-of-state applicants at a future meeting.

Because no information on the location of the well and dates of observations was included, the County was unable to follow up. Because no sender contact information was provided, the Board is unable to respond to the writer.
