## Annual Drinking Water Quality Report 2021

We are pleased to present to you the Annual Quality Water Report for the period of January 1, 2021 to December 31, 2021. This report is designed to inform you about the quality water we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water.

We are pleased to report that our drinking water is safe and meets federal and state requirements.

The following report is provided in compliance with federal regulations and outlines the quality of our drinking water. Sources of drinking water (both tap water and bottled water) include rivers, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and in some cases radioactive material and can pick up substances from the presence of animals or human activity. Our water sources are the Nevette Muir Road and Upper Hill Road wells. The Nevette Muir Road well has a depth of 1,145 feet. The Upper Hill Road well has a depth of 1,137 feet. Our wells draw from the Potomac Aquifer, which is then treated and pumped, into your water distribution system. A source water assessment was performed by the Maryland Department of the Environment (MDE) and is available on their website, mde.maryland.gov.

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791.

Contaminants that may be present in source water include the following. *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. *Inorganic contaminants*, such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming. *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses. *Organic chemical contaminants*, including synthetic and volatile organic chemical, which are by-products of industrial processes and petroleum production. Organic chemical contaminants may also come from gas stations, urban storm water runoff and septic systems. *Radioactive contaminants*, which maybe naturally occurring or be the result of oil and gas production and/or mining activities.

In order to ensure tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by the public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the established limits for a lifetime to have a one-in-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

**Lead** if present at elevated levels can cause serious health problems, especially for pregnant women and young children. Lead in the drinking water is primarily from materials and components associated with service lines and home plumbing. The Somerset County Sanitary District Inc. is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds

to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Though the samples monitored for **Fluoride did not exceed the Maximum Contaminant Level (MCL)**, these samples did exceed the Secondary Maximum Contaminant Level (SMCL) for fluoride in the Drinking Water. Samples collected in 2021 measured in a range of 2.3 mg/l to 3.2 mg/l. Consequently, the U.S.E.P.A. requires that the Sanitary District provide the following language in this public notice regarding the potential effects of consuming water with fluoride levels in excess of the SMCL Standard. The SMCL is based on aesthetics and is not a health concern.

Federal regulations require that Fluoride, which occurs naturally in your water, not exceed a concentration of 4.0 mg/l in the drinking water. This is an enforceable standard called a Maximum Contaminant Level or MCL, and it has been established to protect the public health. Exposure to drinking water levels above 4.0 mg/l for many years may result in some cases in crippling skeletal fluorosis, which is a serious bone disorder. Federal law requires that we notify you when monitoring indicates that the fluoride in your drinking water exceeds 2.0 mg/l. This is intended to alert families about dental problems that might affect children under nine years of age. The fluoride concentration of your water exceeds this guideline.

Fluoride in children's drinking water at levels of approximately 1 mg/l reduces the number of dental cavities. However, some children exposed to levels of fluoride greater than about 2.0 mg/l may develop dental fluorosis. Dental fluorosis in its moderate and severe forms is a brown staining and /or pitting of the permanent teeth. Because dental fluorosis occurs only when developing teeth (before they erupt from the gums) are exposed to elevated Fluoride levels, households without children are not expected to be affected by this level of fluoride. Children under age nine should be provided with alternative sources of drinking water or water that has been treated to remove Fluoride to avoid the possibility of staining and pitting on their teeth. You may also want to contact your dentist about the proper use by young children of fluoride containing products. Your water supplier can lower the concentrations of the fluoride in the water so that you will still receive the benefits of cavity prevention while the possibility of staining and pitting is minimized. Removal of fluoride may significantly increase your water cost. Treatment systems are commercially available for home use. Information on such systems is available by calling the Sanitary District or contacting your local hardware or home products dealer.

Polyfluoroalkyl substances (PFAS) are a large group of more than 4,000 human-made chemicals that have been used since the 1940s in a range of products, including stain/water-resistant fabrics, stain/water-resistant carpeting, cleaning products, paints, cookware, food packaging and fire-fighting foams. These uses of Polyfluoroalkyl substances (PFAS) have led to Polyfluoroalkyl substances (PFAS) entering our environment, where they have been measured by several states in soil, surface water, groundwater and seafood. Some Polyfluoroalkyl substances (PFAS) can last a long time in the environment and in the human body and can accumulate in the food chain.

Currently, there are no federal regulations or Maximum Contaminant Level (MCL) for Polyfluoroalkyl substances (PFAS) in drinking water. The U.S. Environmental Protection Agency has issued a Health Advisory Level of 70 parts per trillion (ppt) for the sum of the Polyfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS) concentrations in drinking water. While not an enforceable regulatory standard, when followed, the U.S. Environmental Protection Agency Health Advisory Level does provide drinking water customers, even the most sensitive populations, with a margin of protection from lifetime exposure from the drinking water to two (2) of the more predominately used Polyfluoroalkyl substances (PFAS); Polyfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS). The Maryland Department of the Environment anticipates that the U.S. Environmental Protection Agency will establish an MCL for Polyfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS) in the near future. This would entail additional monitoring for Polyfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS).

Beginning in 2020, the Maryland Department of the Environment initiated a Polyfluoroalkyl substances (PFAS) monitoring program.

The combined Polyfluorooctanoic Acid (PFOA) and Perfluorooctane Sulfonate (PFOS) concentration from samples taken from the Fairmount, Rumbley and Frenchtown water system in 2021 were below the detection limit. ## **Definitions**

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

*Non-Detects* (*ND*) - laboratory analysis indicates that the constituent is not present.

**Parts per million** (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000 or one ounce in 7,350 gallons of water.

**Parts per billion** (ppb) or Micrograms per liter (ug/l) - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000 or one ounce in 7,350,000 gallons of water.

*Picocuries per liter* (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

**Treatment Technique** (TT) - Treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

**Action Level** (A.L.) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

*Maximum Contaminant Level (MCL)* - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

*Maximum Contaminant Level Goal* (*MCLG*) - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

*Maximum Residual Disinfectant Level* (MRDL) - The highest level of a drinking water disinfectant allowed in drinking water. There is convincing evidence that the addition of a disinfectant to the drinking water is necessary for control microbial contaminants.

*Maximum Residual Disinfectant Level Goal* (MRDLG) - The "Goal" (MRDLG) is the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Millirems per year (mrem/yr and/or mrem) - measure of radiation absorbed by the body.

*Million Fibers per Liter* (*MFL*) - million fibers per liter is a measure of the presence of asbestos fibers that are longer than 10 micrometers.

*Nephelometric Turbidity Unit (NTU)* - nephelometric turbidity unit is a measure of the clarity of water. Turbidity in excess of 5 NTU is just noticeable to the average person.

N/A – not applicable

**Average** – (**Avg.**) – Regulatory compliance with some MCL's are based on running annual average of monthly samples.

**Level 1 Assessment** – A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why coliform bacteria have been found in a water system.

**Level 2 Assessment -** A Level 1 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in a water system on multiple occasions.

The Somerset County Sanitary District, Inc. and the Maryland Department of the Environment routinely monitor for contaminants in your drinking water according to Federal and State laws. This table on the following page shows the results of that monitoring.

The Sanitary District monitors the drinking water daily for pH, Free and Total Chlorine to ensure water quality.

The Sanitary District and the Maryland Department of the Environment have monitored for the following groups of contaminates within the last five years: Volatile Organic Compounds, Synthetic Organic Compounds and Metals.
