Waiver Applications

As of May 02, 2022, MDE has received 253 applications for waivers from testing; 60 have been approved, 115 did not meet the strict requirements for approval, and the remaining 78 are under review at this time. It should be noted that, due to the rigorous review needed for proper processing of the applications, MDE has reached out to the applicants and advised them that they may wish to apply for a 12-month deferral.
